SUMMARY

Appropriates moneys from General Fund to Emergency Board for allocations during biennium.

Appropriates moneys from General Fund to specified state agencies for biennial expenses.

Modifies certain biennial appropriations made from General Fund to specified state agencies and Emergency Board.

Establishes and modifies limitations on expenditures for certain biennial expenses for specified state agencies.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to state financial administration; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 2, chapter 519, Oregon Laws 2019, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Commission for the Blind, is increased by \$500,000 for the purchase of vending machine equipment for the commission's Business Enterprise Program and for the case management migration update project.

SECTION 2. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 3, chapter 519, Oregon Laws 2019, as the maximum limit for payment of expenses from federal funds collected or received by the Commission for the

2 **equipment for the commission’s Business Enterprise Program and for**
3 **the case management migration update project.**

4 **SECTION 3. Notwithstanding any other provision of law, the Gen-**
5 **eral Fund appropriation made to the Oregon Health Authority by sec-**
6 **tion 1 (1), chapter 695, Oregon Laws 2019, for the biennium ending June**
7 **30, 2021, for Health Systems, Health Policy and Analytics, and Public**
8 **Health, is decreased by \$217,493,490.**

9 **SECTION 4. Notwithstanding any other provision of law, the Gen-**

13 **SECTION 5. Notwithstanding any other law limiting expenditures,**

16 **imum limit for payment of expenses from lottery moneys allocated**
17 **from the Administrative Services Economic Development Fund to the**
18 **Oregon Health Authority, for Health Systems and Health Policy and**
19 **Analytics, is increased by \$576,000.**

20 **SECTION 6. Notwithstanding any other law limiting expenditures,**

18 Income recoveries, Women, Infants and Children Program food re-

21 gram and emergency preparedness and response services, but exclud-
22 ing lottery funds and federal funds not described in section 2, chapter

25 SECTION 9. Notwithstanding any other law limiting expenditures,
26 the limitation on expenditures established by section 2 (3), chapter 695,
27 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
28 imum limit for payment of expenses from fees, moneys or other reve-
29 nues, including Miscellaneous Receipts, tobacco tax receipts,
30 recreational marijuana tax receipts, provider taxes, Medicare receipts
31 and federal funds for indirect cost recovery, Supplemental Security

1 **Income recoveries, Women, Infants and Children Program food re-**
2 **bates, the Coordinated School Health Program, the Edward Byrne**
3 **Memorial State and Local Law Enforcement Assistance Grant Pro-**
4 **gram and emergency preparedness and response services, but exclud-**
5 **ing lottery funds and federal funds not described in section 2, chapter**

9 **SECTION 10. Notwithstanding any other law limiting expenditures,**

12 **imum limit for payment of expenses from fees, moneys or other reve-**
13 **nues, including Miscellaneous Receipts, tobacco tax receipts,**
14 **recreational marijuana tax receipts, provider taxes, Medicare receipts**
15 **and federal funds for indirect cost recovery, Supplemental Security**
16 **Income recoveries, Women, Infants and Children Program food re-**
17 **bates, the Coordinated School Health Program, the Edward Byrne**
18 **Memorial State and Local Law Enforcement Assistance Grant Pro-**
19 **gram and emergency preparedness and response services, but exclud-**

26 **imum limit for payment of expenses from federal funds, excluding**
27 **federal funds described in section 2, chapter 695, Oregon Laws 2019,**
28 **collected or received by the Oregon Health Authority, for Health Sys-**
29 **tems, Health Policy and Analytics, and Public Health, is increased by**
30 **\$1,281,249,887.**

31 **SECTION 12. Notwithstanding any other law limiting expenditures,**

1 the limitation on expenditures established by section 4 (2), chapter 695,
2 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
3 imum limit for payment of expenses from federal funds, excluding
4 federal funds described in section 2, chapter 695, Oregon Laws 2019,
5 collected or received by the Oregon Health Authority, for the Oregon
6 State Hospital, is decreased by \$4,890,770.

7 SECTION 13. Notwithstanding any other law limiting expenditures,
8 the limitation on expenditures established by section 4 (3), chapter 695,
9 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
10 imum limit for payment of expenses from federal funds, excluding
11 federal funds described in section 2, chapter 695, Oregon Laws 2019,
12 collected or received by the Oregon Health Authority, for central ser-
13 vices, state assessments and enterprise-wide costs, is decreased by
14 \$209,985.

15 SECTION 14. Notwithstanding any other law limiting expenditures,
16 the limitation on expenditures established by section 6, chapter 695,
17 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
18 imum limit for payment of expenses by the Public Employees' Benefit
19 Board from the Public Employees' Revolving Fund for benefit plan
20 premiums and self-insurance, is increased by \$60,000,000.

21 SECTION 15. Notwithstanding any other law limiting expenditures,
22 the limitation on expenditures established by section 7, chapter 695,
23 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
24 imum limit for payment of expenses by the Oregon Educators Benefit
25 Board from the Oregon Educators Revolving Fund for benefit plan
26 premiums and self-insurance, is increased by \$62,000,000.

27 SECTION 16. Notwithstanding any other provision of law, the Gen-
28 eral Fund appropriation made to the Department of Justice by section
29 1, chapter 608, Oregon Laws 2019, for the biennium ending June 30,
30 2021, for the payment of expenses of district attorneys, is increased by
31 \$500,000 for grand jury recordation services, a statewide contract for

1 transcription service, statewide storage and archiving of grand jury
2 recordings and transcripts and technical assistance support for re-
3 cording equipment.

4 SECTION 17. Notwithstanding any other law limiting expenditures,
5 the limitation on expenditures established by section 2 (1), chapter 692,
6 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
7 imum limit for payment of expenses from fees, moneys or other reve-
8 nues, including Miscellaneous Receipts, but excluding lottery funds
9 and federal funds, collected or received by the Department of Justice,
10 for the Office of the Attorney General and administration, is increased
11 by \$435,000 for grand jury recordation services, a statewide contract for
12 transcription service and the statewide storage and archiving of grand
13 jury recordings and transcripts.

14 SECTION 18. Notwithstanding any other law limiting expenditures,
15 the limitation on expenditures established by section 2 (6), chapter 692,
16 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
17 imum limit for payment of expenses from fees, moneys or other reve-
18 nues, including Miscellaneous Receipts, but excluding lottery funds
19 and federal funds, collected or received by the Department of Justice,
20 for the General Counsel Division, is increased by \$328,935 for the
21 Business Transactions Section.

22 SECTION 19. Notwithstanding any other law limiting expenditures,
23 the limitation on expenditures established by section 3 (3), chapter 692,
24 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-
25 imum limits for payment of expenses from federal funds collected or
26 received by the Department of Justice, for the Crime Victim and Sur-
27 vivor Services Division, is increased by \$450,188 for Human Trafficking
28 Intervention grants.

29 SECTION 20. Notwithstanding any other provision of law, the Gen-
30 eral Fund appropriation made to the Department of Justice by section
31 1 (2), chapter 692, Oregon Laws 2019, for the biennium ending June 30,

1 **2021, for the Appellate Division, is decreased by \$28,590.**

2 **SECTION 21. Notwithstanding any other provision of law, the Gen-**
3 **eral Fund appropriation made to the Department of Justice by section**
4 **1 (3), chapter 692, Oregon Laws 2019, for the biennium ending June 30,**
5 **2021, for the Criminal Justice Division, is decreased by \$459,754.**

6 **SECTION 22. Notwithstanding any other provision of law, the Gen-**
7 **eral Fund appropriation made to the Department of Justice by section**
8 **1 (4), chapter 692, Oregon Laws 2019, for the biennium ending June 30,**
9 **2021, for the Crime Victim and Survivor Services Division, is decreased**
10 **by \$52,106.**

11 **SECTION 23. Notwithstanding any other provision of law, the Gen-**
12 **eral Fund appropriation made to the Department of Justice by section**
13 **1 (5), chapter 692, Oregon Laws 2019, for the biennium ending June 30,**
14 **2021, for Defense of Criminal Convictions, is decreased by \$2,281,591.**

15 **SECTION 24. Notwithstanding any other law limiting expenditures,**
16 **the limitation on expenditures established by section 2 (2), chapter 692,**
17 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**
18 **imum limit for payment of expenses from fees, moneys or other reve-**
19 **nues, including Miscellaneous Receipts, but excluding lottery funds**
20 **and federal funds, collected or received by the Department of Justice,**
21 **for the Appellate Division, for the defense of criminal convictions, is**
22 **decreased by \$328,554.**

23 **SECTION 25. Notwithstanding any other law limiting expenditures,**

29 **for the Trial Division, for the defense of criminal convictions, is de-**
30 **creased by \$440,668.**

18 imum limit for payment of expenses from the Employer Incentive

20 the Public Employees Retirement Board, is decreased by \$35,248,198.

21 **SECTION 342.** (1) In addition to and not in lieu of any other ap-
22 propriation, there is appropriated to the Emergency Board, for the
23 biennium ending June 30, 2021, out of the General Fund, the amount
24 of \$100,000,000, to be allocated to the Oregon Health Authority or the
25 Department of Human Services for caseload costs or other budget
26 challenges that the agency is unable to mitigate.

 5 maximum limit for payment of expenses from fees, moneys or other

 8 tion, but excluding lottery funds and federal funds not described in
 9 section 2, chapter 614, Oregon Laws 2019, collected or received by the
 10 Department of Transportation, for rail, is decreased by \$5,106,587.
