

# House Bill 4304

Sponsored by Representative KOTEK (at the request of Joint Committee on the Second Special Session of 2020)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies requirements relating to certain fiscal reports.

Establishes, modifies and repeals certain transfers of moneys from funds and accounts to General Fund.

Modifies law relating to costs for Oregon transparency website.

Directs Oregon Department of Administrative Services to report on certain terms in certain collective bargaining agreements.

Modifies authorized debt service payments.

Directs Public Employees Retirement Board to submit proposals for crediting amounts to funds or accounts. Repeals transfers of certain moneys to certain funds.

Directs Legislative Assembly to reflect balances of General Fund appropriations made to judicial and legislative departments, and adjustments thereto, in appropriation measures.

Establishes and modifies programs for economic development.

Modifies procedure for payment to children's advocacy centers. Modifies permissible uses of moneys in certain Department of Justice account.

Modifies permissible uses for certain moneys allocated to Housing and Community Services Department. Transfers moneys for department purposes. Provides for distribution of certain federal moneys by department. Repeals certain pilot programs within Housing and Community Services Department and Department of Human Services. Abolishes Wildfire Damage Housing Relief Account.

Permits use of certain revenues for operating costs of Oregon Department of Aviation.

Modifies operative date for provisions relating to in-home care.

Modifies procedure for expenditures from Water Supply Development Account.

Authorizes use of Early Learning Account for construction of facilities. Specifies amounts transferred to education accounts.

Authorizes use of Connect Oregon Fund for Coos Bay rail project.

Authorizes contract for study related to wildfire costs.

Encourages recipients of grants from Student Investment Account to prioritize use of grant moneys for purpose of meeting students' mental or behavioral health needs. Authorizes school district or public charter school that submitted grant application or entered into grant agreement for moneys from Student Investment Account for 2020-2021 school year to submit amended grant application or amended grant agreement.

Declares emergency, effective on passage.

**FISCAL REPORTING**

**SECTION 1.** ORS 293.229 is amended to read:

293.229. (1) Not later than October 1 of each fiscal year, each state agency shall submit a report to the Legislative Fiscal Office that describes the status of that agency's liquidated and delinquent accounts and efforts made by that agency to collect liquidated and delinquent accounts during the previous fiscal year. The report required under this subsection shall be in a form prescribed by the Legislative Fiscal Office and shall include but not be limited to:

(a) Beginning balance and total number of all liquidated and delinquent accounts;

(b) New liquidated and delinquent accounts added during the last preceding fiscal year;

(c) Total collections of liquidated and delinquent accounts;

(d) Total amount and total number of liquidated and delinquent accounts that have been written off;

(e) Total number and ending balance of all liquidated and delinquent accounts;

(f) Total amount of liquidated and delinquent accounts assigned to the Department of Revenue and the total amount collected by the department under ORS 293.250;

(g) Total amount of liquidated and delinquent accounts assigned to private collection agencies and the total amount collected by private collection agencies under ORS 293.231;

(h) Total number and total amount of all liquidated and delinquent accounts exempted under ORS 293.233;

(i) Total number and ending balance of all liquidated and delinquent accounts that have been placed in suspended collection status under ORS 305.155; and

(j) A statement indicating whether the agency has liquidated and delinquent accounts that are not exempt under ORS 293.233, or are otherwise prohibited or exempted by law from assignment, for which no payment has been received for more than 90 days and that have not been assigned to the Department of Revenue under ORS 293.231.

(2) If a state agency reports under subsection (1) of this section that the total ending balance of its liquidated and delinquent accounts is \$50 million or greater, the state agency shall, not later than three months after it submits the report under subsection (1) of this section, submit an additional report to the committees or interim committees of the Legislative Assembly related to ways and means that:

(a) Describes major categories of liquidated and delinquent accounts held by the state agency;

(b) Describes circumstances under which the state agency writes off or adjusts liquidated and delinquent amounts or removes an account from liquidated and delinquent status;

(c) Describes actions undertaken by the state agency to reduce the amount of liquidated and delinquent debt owed to it at the end of each fiscal year; and

(d) Sets forth a plan for future actions that will reduce the amount of liquidated and delinquent debt owed to the state agency at the end of each fiscal year and describes any additional resources that are necessary to carry out the plan.

(3) The Legislative Fiscal Office shall produce an annual report not later than *[December 31]* **February 1** of each fiscal year on the status of liquidated and delinquent accounts of state agencies and the judicial branch of state government. The report shall be based on the reports submitted by state agencies as required in this section and on reports submitted by the judicial branch of state government under ORS 1.195.

(4) The report required under subsection (3) of this section shall:

1 (a) List those state agencies, including the judicial branch of state government, that have liqui-  
 2 dated and delinquent accounts that are not exempt under ORS 1.198, 1.199 or 293.233, or are other-  
 3 wise prohibited or exempted by law from assignment, for which no payment has been received for  
 4 more than 90 days and that have not been assigned to a private collection agency or to the De-  
 5 partment of Revenue under ORS 1.197 or assigned to the Department of Revenue under 293.231;

6 (b) List separately information about the liquidated and delinquent accounts of the Secretary  
 7 of State, the State Treasurer, other state agencies in the executive branch of state government and  
 8 the judicial branch of state government; and

9 (c) Include any other information the Legislative Fiscal Office determines is necessary to de-  
 10 scribe the status of liquidated and delinquent accounts across offices and branches of state govern-  
 11 ment.

12 (5) Notwithstanding ORS 293.227, as used in this section, “state agency” has the meaning given  
 13 that term in ORS 293.226, except that it:

14 (a) Does not include the judicial department as defined in ORS 174.113 or the legislative de-  
 15 partment as defined in ORS 174.114; and

16 (b) Includes public universities listed in ORS 352.002 and Oregon Health and Science University,  
 17 notwithstanding ORS 352.138 and 353.100.

18 **SECTION 2.** ORS 293.252 is amended to read:

19 293.252. (1) The Oregon Department of Administrative Services shall monitor state agency debt  
 20 collection functions described by law and assist state agencies in efforts to improve the collection  
 21 of delinquent debts owed to state agencies. The department’s duties under this subsection include,  
 22 but are not limited to:

23 (a) Providing training to state agencies regarding processing and managing accounts receivable  
 24 in compliance with applicable law and state policies.

25 (b) Providing technical assistance to state agencies in resolving challenges in processing and  
 26 managing accounts receivable and developing financial administrative systems to improve the han-  
 27 dling of liquidated and delinquent accounts.

28 (c) Developing performance standards for state debt collection, including but not limited to  
 29 standards defining what constitutes liquidated and delinquent accounts and when debt may be  
 30 written off pursuant to ORS 293.240.

31 (d) Working with state agencies to improve the quality and value of data that each state agency  
 32 submits to the Legislative Fiscal Office for purposes of ORS 293.229.

33 (e) Submitting an annual management report to the Legislative Assembly not later than [*De-*  
 34 *cember 31*] **February 1** of each fiscal year, in conjunction with the report of the Legislative Fiscal  
 35 Office produced under ORS 293.229, that identifies important issues and significant trends in state  
 36 agency debt collection practices and describes and evaluates efforts by state agencies to improve  
 37 the collection of delinquent debt.

38 (2) The department shall adopt policies:

39 (a) Providing guidance for the collection of liquidated and delinquent accounts owing to state  
 40 agencies.

41 (b) Setting procedures for state agencies to account for and manage information regarding the  
 42 agency’s liquidated and delinquent accounts.

43 (c) After consultation with the Attorney General, setting criteria for effective and efficient as-  
 44 signment of liquidated and delinquent accounts to the Department of Revenue or private collection  
 45 agencies, and setting performance measurements to be used in the application of the criteria.

1 (d) For the allocation, form and amount of charges or fees added to liquidated and delinquent  
2 accounts under ORS 293.231, 293.250 and 697.105.

3 (e) Setting exemptions or adjustments for state agencies that are prohibited by law from adding  
4 or collecting fees under ORS 293.231, 293.250 or 697.105 and for agencies for which the addition or  
5 collection of the fees is not feasible given the agency resources available for collection of accounts  
6 receivable.

7 (f) For the improvement of communications regarding liquidated and delinquent accounts among  
8 state agencies and between private collection agencies and the Department of Revenue.

9 (g) Describing conditions under which a state agency may request and collect Social Security  
10 numbers in accordance with state and federal law when it is reasonably foreseeable that a person  
11 may owe the state agency a liquidated and delinquent amount as a result of a transaction or activ-  
12 ity.

13 (h) After consultation with the Attorney General, setting criteria under which state agencies,  
14 the Department of Revenue and private collection agencies may propose and accept offers of com-  
15 promise as provided in ORS 293.240.

16 (3) As used in this section, “state agency” has the meaning given that term in ORS 293.226,  
17 except that it does not include the judicial department as defined in ORS 174.113, the Secretary of  
18 State or the State Treasurer.

19 **SECTION 3.** ORS 291.227 is amended to read:

20 291.227. (1)(a) As part of the development of the legislatively adopted budget, each state agency  
21 that employs more than 100 employees shall report to the Joint Committee on Ways and Means the  
22 state agency’s maximum supervisory ratio for the biennium.

23 (b) Before submitting the report to the committee, a state agency shall provide a copy of the  
24 report to all labor organizations that represent employees of the state agency.

25 (2) A state agency must determine its maximum supervisory ratio by starting from a baseline  
26 ratio of one to 11 and adjusting the ratio based on some or all of the following factors:

27 (a) Safety of the public or of state agency employees;

28 (b) Geographic location of the agency’s employees;

29 (c) Complexity of the agency’s duties;

30 (d) Industry best practices and standards;

31 (e) Size and hours of operation of the agency;

32 (f) Unique personnel needs of the agency, including the agency’s use of volunteers or seasonal  
33 or temporary employees, or the exercise of supervisory authority by agency supervisory employees  
34 over personnel who are not agency employees; and

35 (g) Financial scope and responsibility of the agency.

36 (3) The Joint Committee on Ways and Means shall review the maximum supervisory ratios re-  
37 ported by state agencies. [*The committee shall include the maximum supervisory ratio in a budget*  
38 *report or budget note for each state agency that reported a maximum supervisory ratio.*]

39 (4) Subject to subsection (5) of this section, a state agency whose actual supervisory ratio is  
40 greater than its maximum supervisory ratio may not fill a supervisory position.

41 (5)(a) The Oregon Department of Administrative Services may exempt a state agency from the  
42 limitations of subsection (4) of this section if the department determines that an additional supervi-  
43 sory position is reasonably necessary to the state agency. The department must make the determi-  
44 nation with reference to some or all of the factors set forth in subsection (2) of this section.

45 (b) At least five business days before granting an exemption under this subsection, the depart-

1 ment shall notify all labor organizations that represent employees of the state agency of its intent  
2 to grant the exemption.

3 (6)(a) The department shall, once per quarter, produce reports on the actual supervisory ratio  
4 of each state agency. The reports must include data on job families within each state agency to the  
5 extent such data is reasonably available.

6 (b) The department shall make the reports publicly available on the Internet and shall notify  
7 all labor organizations that represent state employees when the reports are available.

8 (7) The department may adopt rules for the administration of this section, including rules gov-  
9 erning how temporary, seasonal or part-time employees are accounted for in the calculation of a  
10 supervisory ratio.

11 (8) As used in this section:

12 (a) "Job families" means groups of occupations based upon work performed, skills, education,  
13 training and credentials.

14 (b) "Legislatively adopted budget" has the meaning given that term in ORS 291.002.

15 (c)(A) "State agency" means all state officers, boards, commissions, departments, institutions,  
16 branches, agencies, divisions and other entities, without regard to the designation given to those  
17 entities, that are within the executive branch of government as described in Article III, section 1,  
18 of the Oregon Constitution.

19 (B) "State agency" does not include:

20 (i) The legislative department as defined in ORS 174.114;

21 (ii) The judicial department as defined in ORS 174.113;

22 (iii) The Public Defense Services Commission;

23 (iv) The Secretary of State and the State Treasurer;

24 (v) Semi-independent state agencies listed in ORS 182.454;

25 (vi) The Oregon Tourism Commission;

26 (vii) The Oregon Film and Video Office;

27 (viii) Public universities listed in ORS 352.002;

28 (ix) The Oregon Health and Science University;

29 (x) The Travel Information Council;

30 (xi) Oregon Corrections Enterprises;

31 (xii) The Oregon State Lottery Commission;

32 (xiii) The State Accident Insurance Fund Corporation;

33 (xiv) The Oregon Utility Notification Center;

34 (xv) Oregon Community Power;

35 (xvi) The Citizens' Utility Board;

36 (xvii) A special government body as defined in ORS 174.117;

37 (xviii) Any other public corporation created under a statute of this state and specifically desig-  
38 nated as a public corporation; and

39 (xix) Any other semi-independent state agency denominated by statute as a semi-independent  
40 state agency.

41 (d) "Supervisory employee" has the meaning given that term in ORS 243.650.

42 (e) "Supervisory ratio" means the ratio of employees who are supervisory employees to em-  
43 ployees who are not supervisory employees.

**OREGON MEDICAL BOARD**

**SECTION 4. Section 6, chapter 643, Oregon Laws 2019, is repealed.**

**OREGON TRANSPARENCY WEBSITE**

**SECTION 5.** ORS 276A.253 is amended to read:

276A.253. (1)(a) The State Chief Information Officer shall maintain and make available an Oregon transparency website. The website must allow any person to view information that is a public record and is not exempt from disclosure under ORS 192.311 to 192.478, including but not limited to information described in subsection (3) of this section. The State Chief Information Officer shall provide on the home page of the website a method for users to offer suggestions regarding the form or content of the website.

(b) The Oregon Department of Administrative Services shall assist the State Chief Information Officer in performing duties under paragraph (a) of this subsection to the extent the State Chief Information Officer deems the assistance necessary.

(2) State agencies and education service districts, to the extent practicable and subject to laws relating to confidentiality, when at no additional cost, using existing data and existing resources of the state agency or education service district and without reallocation of resources, shall:

(a) Furnish information to the Oregon transparency website by posting reports and providing links to existing information system applications in accordance with standards that the State Chief Information Officer establishes; and

(b) Provide the information in the format and manner that the State Chief Information Officer requires.

(3) To the extent practicable and subject to laws relating to confidentiality, when at no additional cost, using existing data and existing resources of the state agency or education service district and without reallocation of resources, the Oregon transparency website must contain information about each state agency and education service district, including but not limited to:

(a) Annual revenues of state agencies and education service districts;

(b) Annual expenditures of state agencies and education service districts;

(c) Annual human resources expenses, including compensation, of state agencies and education service districts;

(d) Annual tax expenditures of state agencies, including, when possible, the identity of the recipients of each tax expenditure;

(e) For each state agency, a description of the percentage of expenditures made in this state and the percentage of expenditures made outside this state under all contracts for goods or services the state agency enters into during each biennium;

(f) A prominently placed graphic representation of the primary funding categories and approximate number of individuals that the state agency or the education service district serves;

(g) A description of the mission, function and program categories of the state agency or education service district;

(h) A copy of any audit report that the Secretary of State issues for the state agency or the education service district;

(i) The local service plans of the education service districts;

(j) A copy of each report required by statute for education service districts; and

(k) A copy of all notices of public meetings of the education service districts.

(4) In addition to the information described in subsection (3) of this section:

1 (a) The State Chief Information Officer shall post on the Oregon transparency website notices  
2 of public meetings the state agency must provide under ORS 192.640. If the state agency maintains  
3 a website where minutes or summaries of the public meetings are available, the state agency shall  
4 provide the State Chief Information Officer with the link to the state agency website for posting on  
5 the Oregon transparency website.

6 (b) The State Chief Information Officer shall post on the Oregon transparency website a link for  
7 the website that the Secretary of State maintains for rules that the state agency adopts. If the state  
8 agency maintains a website where the state agency posts the rules, or where any information re-  
9 lating to the rules of the agency is posted, the state agency shall provide the State Chief Information  
10 Officer with the link to the website for posting on the Oregon transparency website.

11 (c) The State Chief Information Officer shall provide links on the Oregon transparency website  
12 for information that the State Chief Information Officer receives concerning contracts and subcon-  
13 tracts that a state agency or education service district enters into, to the extent that disclosing the  
14 information is allowed by law and the information is already available on websites that the state  
15 agency or education service district maintains. To the extent available, the information to which the  
16 State Chief Information Officer links under this section must include:

17 (A) Information on professional, personal and material contracts;

18 (B) The date of each contract and the amount payable under the contract;

19 (C) The period during which the contract is or was in effect; and

20 (D) The names and addresses of vendors.

21 (d) The State Chief Information Officer shall provide an economic development section on the  
22 Oregon transparency website for posting of information submitted to the State Chief Information  
23 Officer by state agencies responsible for administering specific economic development programs. The  
24 section shall include, but not be limited to, the following information, if it is already collected or  
25 available within an existing database maintained by the state agency in the course of administering  
26 the economic development program:

27 (A) The names of filmmakers or companies that have received reimbursements from the Oregon  
28 Production Investment Fund under ORS 284.368 and the amount of each reimbursement;

29 (B) The amount of revenue bonds issued under ORS 285A.430 for the Beginning and Expanding  
30 Farmer Loan Program, the names of persons who received loans under the program and the amount  
31 of the loan;

32 (C) The names of persons who received grants, loans or equity investments from the Oregon  
33 Innovation Council under ORS 284.742 and the purpose and amount of the grant, loan or equity in-  
34 vestment;

35 (D) Copies of, or links to, annual reports required to be filed under ORS 285C.615 under the  
36 strategic investment program;

37 (E) Copies of, or links to, annual certifications required to be filed under ORS 285C.506 for the  
38 business development income tax exemption; and

39 (F) Information required to be posted on the Oregon transparency website under ORS 276A.256.

40 (e) The information reported under paragraph (d) of this subsection:

41 (A) May not include proprietary information; and

42 (B) Shall be provided to the State Chief Information Officer by the state agency in the format  
43 and manner required by the State Chief Information Officer.

44 (f) The State Chief Information Officer shall post on the Oregon transparency website informa-  
45 tion describing the process for requesting copies of public records from a public body, including a

1 link to the public records section of the Department of Justice webpage. At the request of a state  
2 agency or education service district, the State Chief Information Officer shall include a link to a  
3 location on the webpage of the agency or district that describes the process for requesting public  
4 records from the agency or district.

5 (5) In operating, refining and recommending enhancements to the Oregon transparency website,  
6 the State Chief Information Officer and the Transparency Oregon Advisory Commission created in  
7 ORS 276A.259 shall consider and, to the extent practicable, adhere to the following principles:

8 (a) The website must be accessible without cost and be easy to use;

9 (b) Information included on the Oregon transparency website must be presented using plain,  
10 easily understandable language; and

11 (c) The website should teach users about how state government and education service districts  
12 work and provide users with the opportunity to learn something about how state government and  
13 education service districts raise and spend revenue.

14 (6) If a state agency or an education service district is not able to include information described  
15 in this section on the Oregon transparency website because of the lack of availability of information  
16 or cost in acquiring information, the Transparency Oregon Advisory Commission created in ORS  
17 276A.259 shall list the information that is not included for the state agency or education service  
18 district in the commission's report to the Legislative Assembly required under ORS 276A.259.

19 (7)(a) For the purpose of providing transparency in the revenues, expenditures and budgets of  
20 the following entities, the State Chief Information Officer shall include on the Oregon transparency  
21 website a page that provides links to websites established by:

22 (A) Local governments, as defined in ORS 174.116.

23 (B) Special government bodies, as defined in ORS 174.117.

24 (C) Semi-independent state agencies listed in ORS 182.454.

25 (D) Public universities listed in ORS 352.002.

26 (E) Public university statewide programs operated by a public university listed in ORS 352.002.

27 (F) The Oregon Health and Science University.

28 (G) The Oregon Tourism Commission.

29 (H) The Oregon Film and Video Office.

30 (I) The Travel Information Council.

31 (J) The Children's Trust Fund of Oregon Foundation.

32 (K) Oregon Corrections Enterprises.

33 (L) The State Accident Insurance Fund Corporation.

34 (M) The Oregon Utility Notification Center.

35 (N) Any public corporation created under a statute of this state and specifically designated as  
36 a public corporation.

37 (b) The State Chief Information Officer shall include a link to an entity's website after receiving  
38 a request from the entity and shall consider recommendations from the Transparency Oregon Advi-  
39 sory Commission for including other links to websites of the entities listed in paragraph (a) of this  
40 subsection.

41 (c) At the request of any local government, as defined in ORS 174.116, or special government  
42 body, as defined in ORS 174.117, the State Chief Information Officer shall include on the Oregon  
43 transparency website notices of public meetings required to be provided under ORS 192.640 by the  
44 local government or special government body. The local government or special government body  
45 must submit public meeting notice information in the format and manner required by the State Chief



1 Information Officer.

2 (d) The office of the State Chief Information Officer shall include a prominent link on the home  
3 page of the Oregon transparency website for information posted to the page described in paragraph  
4 (a) of this subsection.

5 **(8) Nothing in this section prohibits the State Chief Information Officer or the Oregon**  
6 **Department of Administrative Services from incurring costs or requesting additional re-**  
7 **sources to develop, maintain or enhance the Oregon transparency website.**

8  
9 **NONSTATE EMPLOYEE COLLECTIVE BARGAINING**

10  
11 **SECTION 6.** ORS 410.612 is amended to read:

12 410.612. (1) For purposes of collective bargaining under ORS 243.650 to 243.806, the Home Care  
13 Commission is the employer of record for home care workers and personal support workers.

14 (2) Except as provided in ORS 410.614 and 410.619, home care workers and personal support  
15 workers may not be considered to be employees of the State of Oregon, an area agency, a support  
16 services brokerage or other public agency.

17 (3)(a) The Oregon Department of Administrative Services shall represent the commission in  
18 collective bargaining negotiations with the certified or recognized exclusive representatives of all  
19 appropriate bargaining units of home care workers and personal support workers. The department  
20 is authorized to agree to terms and conditions of collective bargaining agreements on behalf of the  
21 commission and the Department of Human Services.

22 **(b) The Oregon Department of Administrative Services shall report to the legislative re-**  
23 **view agency, as defined in ORS 291.371, on any new or changed provisions relating to com-**  
24 **penetration in a collective bargaining agreement negotiated under this section.**

25 **SECTION 7.** ORS 329A.430 is amended to read:

26 329A.430. (1) As used in this section:

27 (a) "Certified family child care provider" means an individual who operates a family child care  
28 home that is certified under ORS 329A.280.

29 (b) "Child care subsidy" means a payment made by the state on behalf of eligible children for  
30 child care services provided for periods of less than 24 hours in a day.

31 (c) "Exempt family child care provider" means an individual who provides child care services  
32 in the home of the individual or in the home of the child, whose services are not required to be  
33 certified or registered under ORS 329A.250 to 329A.450 and who receives a child care subsidy.

34 (d) "Family child care provider" means an individual who is a certified, registered or exempt  
35 family child care provider.

36 (e) "Registered family child care provider" means an individual who operates a family child care  
37 home that is registered under ORS 329A.330.

 2 protection and wildfire suppression costs on lands protected by the State Forestry Depart-  
 3 ment and regarding the value of that wildfire protection and wildfire suppression toward the  
 4 protection of private and public assets.

5 (2) The economist contracting with the Oregon Department of Administrative Services  
 6 under subsection (1) of this section shall perform the work in collaboration with a project  
 7 team or technical advisory group convened and overseen by the department. The project  
 8 team or technical advisory group shall consist of the following, each of whom must have  
 9 expertise regarding costs and funding sources for wildfire protection and wildfire sup-  
 10 pression:

11 (a) The following members appointed by the Governor:

12 (A) One representative of the State Forestry Department; and

13 (B) One representative of the Emergency Fire Cost Committee; and

14 (b) The following members jointly appointed by the President of the Senate and the  
 15 Speaker of the House of Representatives:

16 (A) One representative of the Legislative Fiscal Office;

17 (B) One representative of the Legislative Revenue Officer;

18 (C) One representative of the forest industry;

19 (D) One small woodland owner; and

20 (E) Two representatives of public interest groups.

21 (3) The economist and the project team or technical advisory group shall complete the  
 22 work described in subsection (1) of this section and report the resulting findings and rec-  
 23 ommendations to the Governor’s Council on Wildfire Response and to a committee of the  
 24 Legislative Assembly relating to natural resources, in the manner provided under ORS  
 25 192.245, no later than March 1, 2021.

 27 **STUDENT INVESTMENT ACCOUNT**

28  
 29 **SECTION 70.** (1) Notwithstanding ORS 327.180 and for the 2020-2021 school year only, the  
 30 recipient of a grant received under ORS 327.195 is encouraged to prioritize the use of grant  
 31 moneys for the purpose of meeting students’ mental or behavioral health needs.

32 (2)(a) A school district or public charter school that submitted a grant application or  
 33 entered into a grant agreement for moneys to be used for the 2020-2021 school year may  
 34 submit an amended grant application or enter into an amended grant agreement for the  
 35 2020-2021 school year.

36 (b) For the purposes of receiving an amended grant application or amended grant agree-  
 37 ment, the Department of Education may modify or waive processes and requirements pre-  
 38 scribed by ORS 327.185 based on rules adopted by the State Board of Education.

39 (c) The department shall prescribe the format and timelines for the submission of an  
 40 amended grant application or amended grant agreement under this section.

41 (3) Notwithstanding ORS 327.190 and for the 2020-2021 school year only, a grant recipient  
 42 is not required to meet longitudinal performance growth targets. The department may,  
 43 however, develop other applicable performance growth targets and indicators of progress.  
 44 Nothing in this subsection prohibits the department from providing technical assistance un-  
 45 der ORS 327.208 or from administering the intensive program under ORS 327.222.
