

SENATE AMENDMENTS TO SENATE BILL 1703

By JOINT COMMITTEE ON THE SECOND SPECIAL SESSION OF 2020

1 On page 1 of the printed bill, line 3, after the first semicolon insert “creating new provisions;”.
2 Delete lines 19 through 28 and delete page 2 and insert:

3 “(6) Authorize the Director of the Department of Revenue to disclose and give access to infor-
4 mation described in ORS 314.835 to the Director of the Employment Department if the Director of
5 the Department of Revenue determines that the administration of any federal or state law or pro-
6 gram requires the disclosure of the information to enable the Employment Department to verify the
7 identity or income level of any person for purposes related to the emergency or any consequences
8 of the emergency. The information that may be disclosed under this subsection shall be limited to
9 information that is necessary to verify a person’s identity or income level. The Director of the Em-
10 ployment Department shall maintain the confidentiality of the information during and after the state
11 of emergency.

12 “**SECTION 2.** ORS 401.175, as amended by section 1 of this 2020 second special session Act, is
13 amended to read:

14 “401.175. During the existence of an emergency, the Governor may:

15 “(1) Assume complete control of all emergency operations in the area specified in a proclamation
16 of a state of emergency issued under ORS 401.165, direct all rescue and salvage work and do all
17 things deemed advisable and necessary to alleviate the immediate conditions.

18 “(2) Assume control of all police and law enforcement activities in such area, including the ac-
19 tivities of all local police and peace officers.

20 “(3) Close all roads and highways in such area to traffic or by order of the Governor limit the
21 travel on such roads to such extent as the Governor deems necessary and expedient.

22 “(4) Designate persons to coordinate the work of public and private relief agencies operating in
23 such area and exclude from such area any person or agency refusing to cooperate with and work
24 under such coordinator or to cooperate with other agencies engaged in emergency work.

25 “(5) Require the aid and assistance of any state or other public or quasi-public agencies in the
26 performance of duties and work attendant upon the emergency conditions in such area.

27 “[*(6) Authorize the Director of the Department of Revenue to disclose and give access to informa-*
28 *tion described in ORS 314.835 to the Director of the Employment Department if the Director of the*
29 *Department of Revenue determines that the administration of any federal or state law or program re-*
30 *quires the disclosure of the information to enable the Employment Department to verify the identity or*
31 *income level of any person for purposes related to the emergency or any consequences of the emergency.*
32 *The information that may be disclosed under this subsection shall be limited to information that is*
33 *necessary to verify a person’s identity or income level. The Director of the Employment Department*
34 *shall maintain the confidentiality of the information during and after the state of emergency.]*

35 “**SECTION 3.** The amendments to ORS 401.175 by section 2 of this 2020 second special

1 session Act become operative on the earlier of:

2 “(1) The date on which the state of emergency, including any extension of the state of
3 emergency, is no longer in effect; or

4 “(2) March 1, 2021.

5 “SECTION 4. This 2020 second special session Act being necessary for the immediate
6 preservation of the public peace, health and safety, an emergency is declared to exist, and
7 this 2020 second special session Act takes effect on its passage.”.
