**PROPOSED AMENDMENTS TO  
SENATE BILL 5721**

1 On page 7 of the printed bill, delete lines 17 through 45.

2 On page 8, delete lines 1 through 13 and insert:

3 **“SECTION 15. (1) A public university that is carrying out a qualified**  
4 **project shall require each contractor in a contract with an estimated**  
5 **cost of \$200,000 or greater to:**

6 **“(a) Implement an aspirational target of employing apprentices to**  
7 **perform 15 percent of the work hours that workers in apprenticeable**  
8 **occupations perform under the contract, in a manner consistent with**  
9 **the apprentices’ respective apprenticeship training programs;**

10 **“(b) Establish and execute a plan for outreach, recruitment and**  
11 **retention of women, minority individuals and veterans to perform**  
12 **work under the contract, with the aspirational target of having at**  
13 **least 15 percent of total work hours performed by individuals in one**  
14 **or more of those groups; and**

15 **“(c) Require any subcontractor engaged by the contractor to abide**  
16 **by the requirements set forth in paragraphs (a) and (b) of this sub-**  
17 **section, if the work to be performed under the subcontract has an es-**  
18 **timated cost of \$200,000 or greater.**

19 **“(2) On or before February 1 of each year, each public university**  
20 **that is carrying out a qualified project shall report to the Joint Com-**  
21 **mittee on Ways and Means or Joint Interim Committee on Ways and**

1 **Means, as part of the report required under ORS 350.379, on:**

2 **“(a) The amount of work performed on qualified projects by ap-**  
3 **prentices; and**

4 **“(b) The amount of work performed on qualified projects by women,**  
5 **minority individuals and veterans.**

6 **“(3) The requirements of this section are in addition to, and not in**  
7 **lieu of, the requirements imposed under ORS 350.379.**

8 **“(4) The requirements of subsection (1) of this section do not apply**  
9 **to a qualified contract if the public university determines that com-**  
10 **pliance with the requirements would, with respect to the qualified**  
11 **contract:**

12 **“(a) Cause unreasonable expense or delay; or**

13 **“(b) Limit the pool of bidders to fewer than three.**

14 **“(5) As used in this section:**

15 **“(a) ‘Apprentice’ has the meaning given that term in ORS 660.010.**

16 **“(b) ‘Apprenticeable occupation’ has the meaning given that term**  
17 **in ORS 660.010.**

18 **“(c) ‘Apprenticeship training program’ means the total system of**  
19 **apprenticeship that a particular local joint committee, as defined in**  
20 **ORS 660.010, operates, including the local joint committee’s registered**  
21 **standards and all other terms and conditions for qualifying, recruiting,**  
22 **selecting, employing and training apprentices in an apprenticeable**  
23 **occupation.**

24 **“(d) ‘Minority individual’ has the meaning given that term in ORS**  
25 **200.005.**

26 **“(e) ‘Qualified project’ means the following capital construction**  
27 **projects:**

28 **“(A) The Portland State University SB1 Renovation and Expansion**  
29 **referenced in section 1 (1)(k), chapter 661, Oregon Laws 2019; and**

30 **“(B) The University of Oregon Huestis Hall Renovation referenced**

1 **in section 1 (1)(L), chapter 661, Oregon Laws 2019.**

2 **“(f) ‘Veteran’ has the meaning given that term in ORS 408.225.**

3 **“(g) ‘Woman’ has the meaning given that term in ORS 200.005.”.**
