## PROPOSED AMENDMENTS TO SENATE BILL 5721

- On page 7 of the printed bill, delete lines 17 through 45.
- On page 8, delete lines 1 through 13 and insert:
- "SECTION 15. (1) A public university that is carrying out a qualified project shall require each contractor in a contract with an estimated cost of \$200,000 or greater to:
  - "(a) Implement an aspirational target of employing apprentices to perform 15 percent of the work hours that workers in apprenticeable occupations perform under the contract, in a manner consistent with the apprentices' respective apprenticeship training programs;
  - "(b) Establish and execute a plan for outreach, recruitment and retention of women, minority individuals and veterans to perform work under the contract, with the aspirational target of having at least 15 percent of total work hours performed by individuals in one or more of those groups; and
  - "(c) Require any subcontractor engaged by the contractor to abide by the requirements set forth in paragraphs (a) and (b) of this subsection, if the work to be performed under the subcontract has an estimated cost of \$200,000 or greater.
- "(2) On or before February 1 of each year, each public university that is carrying out a qualified project shall report to the Joint Committee on Ways and Means or Joint Interim Committee on Ways and

- 2 "(a) The amount of work performed on qualified projects by ap-3 prentices; and
- "(b) The amount of work performed on qualified projects by women, minority individuals and veterans.
- 6 "(3) The requirements of this section are in addition to, and not in 7 lieu of, the requirements imposed under ORS 350.379.
- "(4) The requirements of subsection (1) of this section do not apply to a qualified contract if the public university determines that compliance with the requirements would, with respect to the qualified contract:
- "(a) Cause unreasonable expense or delay; or
- 13 "(b) Limit the pool of bidders to fewer than three.
- 14 "(5) As used in this section:
- 15 "(a) 'Apprentice' has the meaning given that term in ORS 660.010.
- 16 "(b) 'Apprenticeable occupation' has the meaning given that term 17 in ORS 660.010.
- "(c) 'Apprenticeship training program' means the total system of apprenticeship that a particular local joint committee, as defined in ORS 660.010, operates, including the local joint committee's registered standards and all other terms and conditions for qualifying, recruiting, selecting, employing and training apprentices in an apprenticeable occupation.
- 24 "(d) 'Minority individual' has the meaning given that term in ORS 25 200.005.
- "(e) 'Qualified project' means the following capital construction projects:
- 28 "(A) The Portland State University SB1 Renovation and Expansion 29 referenced in section 1 (1)(k), chapter 661, Oregon Laws 2019; and
  - "(B) The University of Oregon Huestis Hall Renovation referenced

- in section 1 (1)(L), chapter 661, Oregon Laws 2019.
- "(f) 'Veteran' has the meaning given that term in ORS 408.225.
- "(g) 'Woman' has the meaning given that term in ORS 200.005.".
