

Senate Bill 5731

Sponsored by Senator COURTNEY (at the request of Joint Committee on the Third Special Session of 2020)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Emergency Board for allocations during current biennium.

Appropriates moneys to Housing and Community Services Department for certain expenses.
Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to state financial administration; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**
5 **ated to the Emergency Board, for the biennium ending June 30, 2021, out of the General**
6 **Fund, the amount of \$100,000,000 for the purposes for which the Emergency Board lawfully**
7 **may allocate funds.**

8 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**
9 **ated to the Emergency Board, for the biennium ending June 30, 2021, out of the General**
10 **Fund, the amount of \$400,000,000, to be allocated for the state's response to the COVID-19**
11 **pandemic public health emergency.**

12 **SECTION 3. In addition to and not in lieu of any other appropriation, there is appropri-**
13 **ated to the Emergency Board, for the biennium ending June 30, 2021, out of the General**
14 **Fund, the amount of \$100,000,000, to be allocated for the state's wildfire recovery, prevention**
15 **and preparedness activities.**

16 **SECTION 4. (1) In addition to and not in lieu of any other appropriation, there is appropri-**
17 **ated to the Housing and Community Services Department, for the biennium ending June**
18 **30, 2021, out of the General Fund, the amount of \$150,000,000, to provide distributions under**
19 **section 2, chapter _____, Oregon Laws 2020 (third special session) (Enrolled House Bill**
20 **4401).**

21 **(2) In addition to and not in lieu of any other appropriation, there is appropriated to the**
22 **Housing and Community Services Department, for the biennium ending June 30, 2021, out**
23 **of the General Fund, the amount of \$50,000,000, to provide distributions under section 3,**
24 **chapter _____, Oregon Laws 2020 (third special session) (Enrolled House Bill 4401).**

25 **SECTION 5. This 2020 third special session Act being necessary for the immediate pres-**
26 **ervation of the public peace, health and safety, an emergency is declared to exist, and this**
27 **2020 third special session Act takes effect on its passage.**
