In regards to your questions....

Despite COVID, our SB 283 "review of peer-reviewed, independently funded scientific studies of the health effects of exposure to microwave radiation, particularly exposure that results from the use of wireless technologies in schools or similar environments" has been completed and the report is being drafted. The intent is to finalize the report for presentation to an interim committee of the Oregon Legislative Assembly by no later than January 2, 2021. I do not think it will be submitted sooner.

The final report will be assessible to the public via posting on the Oregon Health Authority (OHA), Radiation Protection Services (RPS) website at www.healthoregon.org/rps . I advise EMF Medical Conference attendees and other interested parties to check our website for the report after January 2, 2021.. We do not have a placeholder page.

Thank you for your work and information. I'll share it with appropriate OHA staff.

I've been asked to speak on public policy at the upcoming EMF Medical Conference, and I have a slide on Oregon bill S. 284 for which we are so very grateful. We hope this helps lead the way to protect all of us and especially the children from radiofrequency radiation.

I am also covering the New Hampshire law in my presentation, and they have set up a page for the Commission doing the investigation that houses the NH meeting agendas, minutes, documents and reports. Their final report will be complete by November 1, and will be posted on-line at the above link.

With regard to the Oregon investigation, might your final report be accessible to the public via a similar page with the Oregon legislature or perhaps Radiation Protection Services?

If such a placeholder page already exists, might you be so kind as to send me the link so I can include it in my presentation? I need to submit my slides now to put them in queue for CME

accreditation. If no such page currently exists, might you advise how EMF Medical Conference attendees might access the report following the conference in January?

Is your report still scheduled for submission to the legislature on January 2nd or might it be issued sooner?

The pandemic has made this especially urgent as children are being handed wireless devices with no safety instructions and given unprecedented screen time for schooling, socialization and babysitting while parents work. Concurrently, the industry is forcing toxic small cell antennas in at the curb in the public access way right outside our homes for 5G and the Internet of Things (IoT).

Thanks again for all your hard work, we are so hopeful your final report will initiate action to protect the children ASAP.
