Dear Mr. Howe,

Please allow me to introduce myself, my name is Cece Doucette from Ashland, Massachusetts. I investigated the wireless radiation issue several years ago and helped my schools become the [first in the nation](#) to begin taking precautionary measures with wireless technology.

Other States Examining EMFs Too

I have also helped with many of the [20 man-made radiation bills here in Massachusetts](#), as well as the [law recently passed in New Hampshire](#) to investigate EMFs and 5G in particular. [New York](#) has just filed a similar bill, so it's great that Oregon already has a jump on this.

I understand you are overseeing the investigation into the biological effects of today's wireless radiation as per *Senate Bill 283 Relating to exposure to radiation in schools in this state; and declaring an emergency.*

I am grateful the law "Directs Oregon Health Authority to review peer-reviewed, independently funded scientific studies of health effects of exposure to microwave radiation, particularly exposure that results from use of wireless network technologies in schools and to report results of review to interim committee of Legislative Assembly related to education not later than January 2, 2021."

A Quick Overview of the Issues

I was honored to co-chair the technology panel at the Health in Buildings Roundtable Conference held at the National Institutes of Health. You may find the [short presentations](#) (under ten minutes each) by retired Microsoft Canada President Frank Clegg, scientist Dr. Martin Pall and others especially helpful in understanding the industry's push with technology and the biological risks we all now face, especially children with their developing biological systems.

Protecting Children in School

We recently held an expert forum here in Massachusetts with Dr. David Carpenter of the WHO, Harvard pediatric neurologist Dr. Martha Herbert, senior toxicologist Dr. Ronald Melnick who designed the \$30M U.S. National Toxicology Program study that determined "clear evidence" radiofrequency radiation causes tumors (cancer) and DNA damage, Microsoft's Frank Clegg, child/adolescent social worker and Executive Director of the Environmental Health Trust Theodora Scarato, and myself.

On this journey I have had the privilege of collaborating with many of the world-leading scientists, doctors and public health experts on EMFs. Many of them flew in to Santa Cruz, CA last month for the three-day medical [EMF Conference](#) where we offered 16 CMEs for health care professionals to recognize, diagnose, treat and prevent the skyrocketing rates of microwave sicknesses.

I co-hosted the policy panel for the conference and can put you in touch with the experts. There were several doctors from Oregon in attendance too, and I can connect you with them as well if you'd like.

Safe Technology Training

Four years into my EMF journey I helped establish that non-profit out of Europe with some of the leading experts. There is a very low fee associated with the courses to keep our non-profit afloat, but we would be honored to work with Oregon on whatever policy makers feel is fair for the training. We just want to help educate and protect your citizens ASAP, especially the children and fetuses who are most vulnerable to microwave radiation.

The award-winning film [Generation Zapped](#) is also a terrific way to educate on a broad scale, and it has been shown in many communities, the Massachusetts State House, at the NIH conference referenced above, and even at Google headquarters.

If you haven't seen [Generation Zapped](#) yet, you might want to [watch it with your team](#). It'll help you connect the dots on many of the EMF issues, and I can put you in touch with the scientists, doctors, public health experts and patients in the film.

It won Best Documentary at the D.C. Independent Film Festival and was selected for the United Nations Association Film Festival. It's very well done, factual without fear mongering.

The Fertility Issue

Mr. Howe, when I first started investigating EMFs, it was the fertility studies that got me on my feet. Have you read them yet?

Scientists have taken male human sperm and exposed it to a laptop with the RF antennas turned on. It changed the DNA -- which is our roadmap to grow a proper human, slowed the motility and caused fewer sperm to be viable. In just four hours of exposure. And we had just bought our daughter a laptop for Christmas which she was using right on top of her reproductive organs.

The Urgency

With our personal devices, with a little education we can choose to turn them off or hard-wire them and turn off the RF antennas.

- In our schools, our children do not have control over their environment. The adults do. And today the adults are unwittingly exposing themselves and the children to toxic microwave radiation all day every day from industrial strength mesh wi-fi systems and an increasing number of 1:1 devices pushed in by the industry for their

highly profitable 21st Century Classroom Campaign.

- Meanwhile, the New York Times reports Silicon Valley executives are [sending their children to schools with no technology](#) and [having their nannies sign contracts that there will be no screens near their children](#).
- At home, parents are exposing themselves and their loved ones to RF-emitting cars, routers, cell phones, baby monitors, gaming devices, sound boards, Alexa, wearables and more.
- The industry has already begun replacing analog utility meters with "smart" meters for electricity, water, gas and solar inverters. These constantly pulse toxic EMFs at our families, every day, all day and night with no consideration for who is on the other side of the wall or above basement installations.
- And now the industry is pushing hard and fast to put toxic [5G cell antennas](#) every two to 12 houses at the curb or on our roofs for 5G and the Internet of Things. They've begun to put toxic RF antennas in every product we purchase from appliances to baby diapers so they can harvest our data.

The RF exposure is cumulative, so the longer we are exposed, and simultaneously from multiple sources, the more harm will be done hour after hour by this heavy dosing of modulated/pulsed spiked, erratic microwave radiation.

Although public policy has been known to take a long time, it is critical we invoke the Precautionary Principle as soon as possible.

Mr. Howe, I hope you see how urgent it is that your SB283 research be a top priority so you can report back to the legislature as quickly as possible to protect the children especially. Please invoke emergency measures ASAP.
