## Prescribed Fire (Sections 25–27: Requirements)

- Requires the ODF to:
  - initiate rulemaking to establish Certified Burn Manager program;
  - consult with the Oregon Prescribed Fire Council; and,
  - provide a progress report to the Legislative Assembly by December 2021.
- Rules must allow:
  - prescribed fire across ownership boundaries;
  - person to obtain a permit and comply with conditions; and,
  - obtain consent from relevant landowners.
- Rulemaking must be completed by November 2022.

# Prescribed Fire (Timeline)

Aug. 18 Sep.  $\rightarrow$  Ongoing

#### Mid - 2022

#### Nov. 2022

First RAC meeting.

RAC established a charter and drafting work continues monthly.

ODF plans to present draft rules to Board & request public hearings.

ODF complete rulemaking.



#### Protected Areas (Sections 28–29, all-lands requirements)

- ODF to adopt rules establishing baseline levels of wildfire protection across all areas of the state.
- ODF may provide financial assistance to:
  - form or modify wildfire protection jurisdictions;
  - · develop wildfire protection facilities, equipment; and,
  - invest in training and other resources.
- Requires counties to ensure all lands within the jurisdiction have baseline level or higher wildfire protection by January 2026.
- Timeline:
  - ODF plans to establish RAC in late-2022.




Forestland and Rangeland Restoration and Resiliency Investment Program (Section 18)

- \$20 million for landscape-scale all-lands restoration.
- Convened work group to:
  - Recommend criteria
  - Identify strategic landscapes
- 21–23 Biennium—projects must be completed by June 30, 2023.

## Small Forestland Grant Program (Section 24)

- Small Forestland Owner defined as:
  - Ownerships up to 160 acres west of the Cascade Crest.
  - 640 acres east of the Cascade Crest.
- Prioritize high-risk areas.
- Address multiple resource concerns.
- Reduce the risk of high severity wildfire.
- Funds expended by June 30, 2023.



# **Small Forestland Grant Program**

- Small Parcels (approx. \$750,000)
  - ODF internal competitive to issue landowner rebates
- Firewise USA<sup>™</sup> Grants (approx. \$750,000)
  - Open competitive to Firewise USA<sup>™</sup> Communities or project sponsors
- Small Forestland Grant (approx. \$3.5 million)
  - \$300K max project award.
  - Open competitive to eligible project sponsors.
  - At least 75% of project costs must support fuel reduction on small forestland properties.
