Frequently Recurring

State Wildfire Programs Director: Report every 60 days to the Governor, President of the Senate, Speaker of the House, and relevant interim committees and committee chairs

Sept. 1	Wildfire Programs Advisory Council	Council members must be appointed
Oct. 27	Board of Forestry (BOF)	Adopt by rule WUI definition
Nov. 1	Wildfire Programs Advisory Council	Council must begin meeting regularly
Nov. 30	Department of Forestry (ODF)	Initiate rulemaking to clarify a person may conduct a prescribed fire that burns across land ownership boundaries if the person obtains and complies with a permit and obtains consult from landowners, and to establish a Certified Burn Manager Program
Dec. 1	Department of Forestry (ODF)	Consult with the Oregon Prescribed Fire Council concerning best practices for a Certified Burn Manager Program, and report to the legislature on when the department expects to launch the program
Dec. 31	Investor-Owned Utilities (IOUs)	Must submit first risk-based wildfire protection plan to the Public Utility Commission (PUC)
Dec. 31	Department of Forestry (ODF)	Report to wildfire legislative committees/Director/Council on WUI, risk classes, and mapping rulemaking progress
Dec. 31	Office of Emergency Management (OEM)	Update its statewide emergency plan to prepare for and respond to wildfire emergencies

Jan. 1	Counties	Required to ensure that all lands within the county that are outside of forest protection districts and susceptible to wildfire have baseline level or higher of wildfire protection

Aug. 1 (approx.)	Office of the State Fire Marshal (OSFM)	Biannual report to wildfire legislative committees/Director/Council on defensible space
