## **OREGON CANNABIS COMMISSION**

The Governor has appointed the following individual to the Oregon Cannabis Commission subject to Senate confirmation.<sup>1</sup>

#### **Appointees**

Adie Rae of Portland; New Appointment

#### Term

Rae: November 20, 2021 - November 19, 2025

#### **Appointment/Confirmation Authority**

ORS 475B.952 (2019)

#### Statement of Economic Interest<sup>2</sup>

Not required.

### **Statutory Requirements**<sup>3</sup>

The commission consists of the Public Health Officer or the Public Health Officer's designee and eight members appointed by the Governor and subject to confirmation by the Senate.<sup>4</sup> Gubernatorial appointees must include:

- a registry identification cardholder (TAYLOR);
- a person designated to produce marijuana by a registry identification cardholder (GREY);
- an attending physician (KNOX);
- a person representing the Oregon Health Authority (OURSO);
- a person representing the Oregon Liquor Control Commission (BORUP);
- a local health officer (LEUDTKE);
- a law enforcement officer (BURKE); and
- a person knowledgeable about research proposal grant protocols (RAE).

Members serve four-year terms at the pleasure of the Governor and are eligible for reappointment. The commission must select one of its members as chairperson and another as vice chairperson, for terms and with such duties and powers as the commission determines.<sup>5</sup> A majority of the members of the commission constitutes a quorum for the transaction of business. The commission must meet at least once every quarter and at other times and places specified by the call of the chairperson or a majority of the members of the commission.

#### **Duties and Authority**

The commission advises the Oregon Health Authority on the administration of the Oregon Medical Marijuana Act and the Oregon Liquor Control Commission on the administration of the Adult and Medical Use of Cannabis Act as it relates to registry identification cardholders and primary caregivers.<sup>6</sup>

The commission must:7

- provide advice to the Oregon Health Authority with respect to the administration of the Oregon Medical Marijuana Act;
- provide advice to the Oregon Liquor Control Commission with respect to the administration of the Adult and Medical Use of Cannabis Act related to registry identification cardholders and designated primary caregivers;
- develop a long-term strategic plan for ensuring that cannabis will remain an affordable and therapeutic option for persons with debilitating medical conditions; and
- monitor and study federal laws, regulations, and policies regarding marijuana.
