SUMMARY

Directs Department of Human Services to provide specified services to individuals with brain injuries and to convene Traumatic Brain Injury Advisory Committee. Requires department to report to Legislative Assembly during odd-numbered years of regular sessions on services provided and number of individuals served.

Declares emergency, effective on passage.

A BILL FOR AN ACT

- 2 Relating to brain injuries; and declaring an emergency.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 SECTION 1. (1) As used in this section, "brain injury" means dam-
- 5 age to the brain from an internal or external source that occurs after
- 6 birth and is not congenital, degenerative or hereditary, that results in
- 7 total or partial impairment in critical functions, including but not
- 8 limited to attention, memory, reasoning, problem solving, processing
- 9 speed, decision-making, learning, perception, sensing, speech and lan-
- 10 guage, motor and physical function or psychosocial behavior and is
- 11 of sufficient severity to produce partial or total disability.
- 12 (2)(a) The Department of Human Services shall provide the follow-
- 13 ing services to individuals with brain injuries, delivered in a person-
- 14 centered manner and in collaboration with the individual:
- 15 (A) Service coordination;
- 16 **(B) Resource facilitation;**
- 17 (C) Advocacy; and

- 1 (b) Services provided under this subsection may not include institutionalization, hospitalization or medication.
- (3) The department is authorized, but not required, to contract with 3 or provide grants to third parties to provide services described in 4 subsection (2) of this section. 5
 - (4)(a) The department shall convene a Traumatic Brain Injury Advisory Committee to advise the department in the development of traumatic brain injury programs, services described in subsection (2) of this section and other activities that the department may develop to address the needs of individuals with traumatic brain injuries.
 - (b) The membership of the advisory committee must consist of between six and 12 individuals with experience in traumatic brain injuries and be broadly representative of the geographic areas of this state. At least one-third of the members must have a traumatic brain injury.
 - (c) Members of the advisory committee are entitled to compensation and actual and necessary travel or other expenses incurred in the performance of their official duties as specified for qualified members of boards or commissions in ORS 292,495.
 - SECTION 2. During each regular session of the Legislative Assembly in odd-numbered years, the Department of Human Services shall report to the Joint Committee on Ways and Means and the committees of the Legislative Assembly related to health or human services, in the manner provided in ORS 192.245, on the:
 - (1) Types of services provided under section 1 of this 2022 Act;
- (2) Number of individuals with brain injuries who received services 25 described in section 1 (2) of this 2022 Act; 26
- (3) Barriers faced by individuals with traumatic brain injuries in 27 accessing needed services; and 28
- (4) Needs of individuals with traumatic brain injuries that are not 29 being met by any known provider or other entity in this state. 30
