## Virtual Education in Oregon



### A brief overview:

- Virtual public charter schools have been in Oregon since 2005.
  - Clackamas Web Academy and Oregon Charter
    Academy opened their virtual doors at this time.
- Currently 20 virtual public charter schools or districts in Oregon.
- 13 of these virtual charter schools are in their
  5th year of operation at minimum.

## **Educator Shortages**

Attracting and retaining highly qualified staff.

Professional development and training of staff.



## Virtual School Workforce in Oregon:

- Consistent staffing with increased levels of interest from Highly Qualified Oregon teachers.
  - Virtual Schools have not faced teacher shortage crisis plaguing many brick and mortar schools.
- Virtual Schools are **prepared** to **support** Oregon **students** if 3% cap is raised or removed.

## Quality New Teacher Training:

- Our priority is to prepare classroom teachers for effective online learning
  - 2-week new hire bootcamp, Year-long Coaching and Mentoring, Library of new teacher training videos.
    - Key areas of support: Fostering relationships with students virtually, understanding the instructional environment, professional practice, and data driven instruction.

## Professional Growth and Teacher Development:

- National partnership with SNHU for teachers to provide free M.Ed in online instruction to grow our teachers.
- National partnership with many universities to host student teachers to further strengthen our workforce.

## ODE Standards: Work Group in Action

Perspective of the work happening in that group from a committee member



A common expectation for all virtual programs/school to follow housed within 6 pillars:

- Each pillar looks at a different lens of standards.
- Rigor yet realistic standards.
- Focus on high levels of academic achievement and equitable design of instruction and access to education.
  - 3% cap creates inequitable access to education. In our current structure, home address determines whether a student has access to educational choice.

#### Stemmed from:

- The need of a common set of standards for all virtual learning programs/schools to follow
- Stakeholder feedback has driven the direction of standards
- Resources from other states incorporating a common set of standards successfully.

## Governance Model

A brief overview of charter school annual accountability.



#### Virtual Charter Schools:

- Must have academic goals as part of charter contract with district.
- Annual audits and reports on:
  - Performance of the organization including academics.
    - Annual audit and annual report on
  - Financial audits
- Annual submit to both authorizing district and ODE:
  - Written annual report
  - Performance audit report
  - Financial audit report
  - Accreditation report when necessary
- Current overview structure is correct.
  - A good authorizing district has greater capacity to maintain integrity of the academics and operations of the charter school.
  - ODE already receives annual reports on more audits and presentations than from districts
- Recommendation:
  - As part of the initial charter process, ODE or OSBA could host a training for authorizing districts on how to perform as an authorizer.

## Celebrations From the Representative Schools

## Oregon Charter Academy:

- Accreditation score of 377.5 out of 400
- Accreditation International School of Distinction Award
  - Only 1 out of 79 schools internationally to receive this honor.
    Only school in Oregon and on the west coast.
- Poetry Out Loud state champion.
- 23 of 55 graduating ASCEND (CTE) students have earned industry-recognized certifications, including Certified Clinical Medical Assistant, IT Fundamentals Pro and Oregon Employability Skills.
- eDynamic CTE National Teacher Finalist.
- 1,143 students have earned college credit since the inception of the program.
- Nearly \$1.1 million in scholarships awarded to ORCA seniors.
- Voted Best of the Mid-Valley, "Best Charter School," "Best Leadership," and finalists for "Most Innovative Workplace," "Company Culture," and "Best Boss."

## Cascade Virtual Academy, Insight School of Oregon- Painted Hills, & Destinations Career Academy of Oregon:

3 Virtual Charter Schools within one District Authorizer.

#### 2019-2020 School Year:

- ISORPH: Increased graduation rate by 6.5%.
  - Increased 9<sup>th</sup> grade on track by 27%
- ORDCA: Increased graduation rate by 30% (school opened SY 18-19).
  - Increased 9<sup>th</sup> grade on track by 45%

#### 2020-2021 School Year:

- CVA: Added grades 9-12. CVA opened in 2018-2019 as K-8.
- All 3 schools: Added Flexible Pathway allowing students to work full time and successfully complete high school courses required for graduation.
- All 3 schools: Added individualized pathways or students in CTE. Added semester and guarter-based classes.
- CVA & ISORPH: Added high school credit classes in grades 7 & 8.

#### **Accreditation:**

- ISORPH- Full accreditation June 2016 with Cognia
- ORDCA- Full accreditation June 2021 with Cognia
- CVA- Full accreditation March 2021 with Cognia
