Measure 110 – the Basics

History:

- Voters passed Measure 110, the Drug Addiction Treatment and Recovery Act in Nov 2020

Goal:

- Establish a more equitable and effective approach to substance use disorder treatment.
- Establishes the Oversight and Accountability Council (OAC) with rulemaking, grant making, and all decision and funding authority related to the implementation of M110.
- Requires creation of at least one Behavioral Health Resource Network (BHRN) in each county region
- OAC holds the implementation and oversight power of the BHRN development
- OHA provides technical support and assistance to the council

Key Values and Decisions:

- OAC Key Value: Consistently supporting equity work and support community-based approach
- OAC decision: An applicant may apply for any number of BHRN services, you do not need to be in a fully organized BHRN to apply – this has caused additional unanticipated workload

Challenges and Barriers

OHA missteps:

- Did not request sufficient staffing supports
- Did not adequately support the grantmaking process
- Did not adequately anticipate implications of the current RFGP process
 - Underestimated the number of applicants and time intensive nature of the evaluation review process

M110 Structural challenges:

- Council holds the authority from implementation to oversight and the grantmaking process is complex which takes significant technical expertise to accomplish
 - Members have rapidly taken up this challenge, but it does take time and was a process of learning alongside performing its duties
- M110 unrealistic implementation timelines
- Council made critically needed equity decisions that greatly increase the need for support to the council
 - Example: each individual entity applying separate and apart from an association forming a complete BHRN and applying together

Behavioral Health Resource Network Approval and Funding Process

- The OAC voted to restructured its approval process and the pace of approvals has increased dramatically.
- After the letters of intent to award are sent out, OHA provides orientation and technical assistance to support next steps.
- Providers who are part of a BHRN collaboration within a county region must work cooperatively to establish Memoranda of Understanding (MOU) to complete establishment of a BHRN.

Rubrics and Application Reviews Update

- The OAC wanted each smaller provider to have their own contract so they wouldn't be reliant on larger providers to include them in a BHRN application as well as encourage providers that had not historically worked with OHA
 - The OAC successfully developed a rubric and application process that supported this approach that drove m
- OHA has been supportive of this approach however it did result in an unprecedented number of applications.
 - (333 applications were received procurement requirements stipulate that each application be reviewed twice 666 reviews were required.)
 - OHA provided 138 staff to provide the required reviews of these applications.
 - 125 rubrics were completed by councilmembers
- **Currently all rubrics are complete and with the council**

Rubrics and Application Reviews Update Continued

- As of 5/27/22 the OAC approved its first two complete Behavioral Health Resource Networks (BHRNs), funding drug treatment and recovery services in Harney and Jefferson Counties
- OAC subcommittees also approved applications for Sherman and Coos counties, bringing the number of approved counties to 33.
- The subcommittees are continuing to review applications until completed
- Funding will be released no later than 20 days after a BHRN receives full approval and all agreements between OHA and the providers are executed.

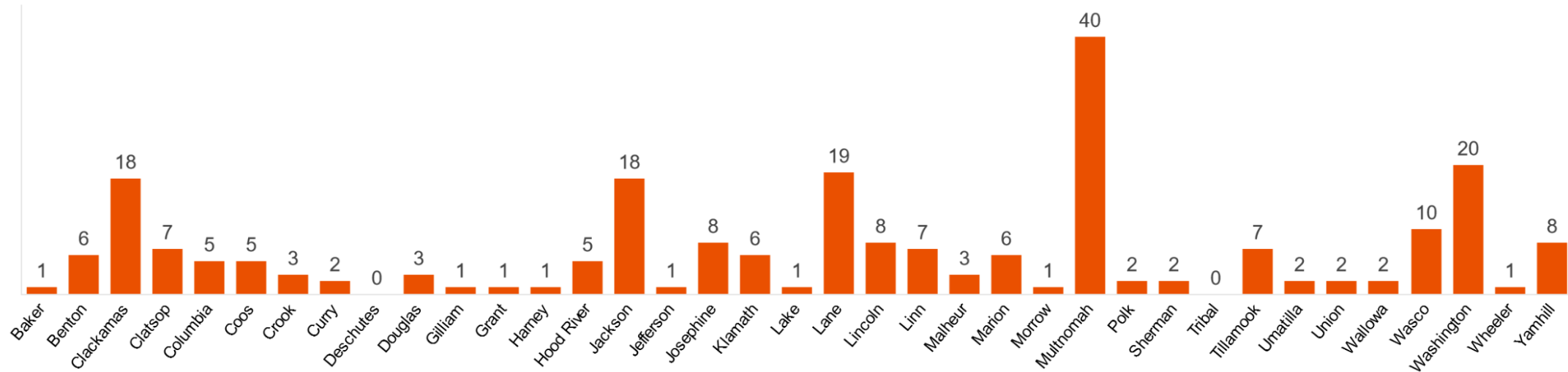

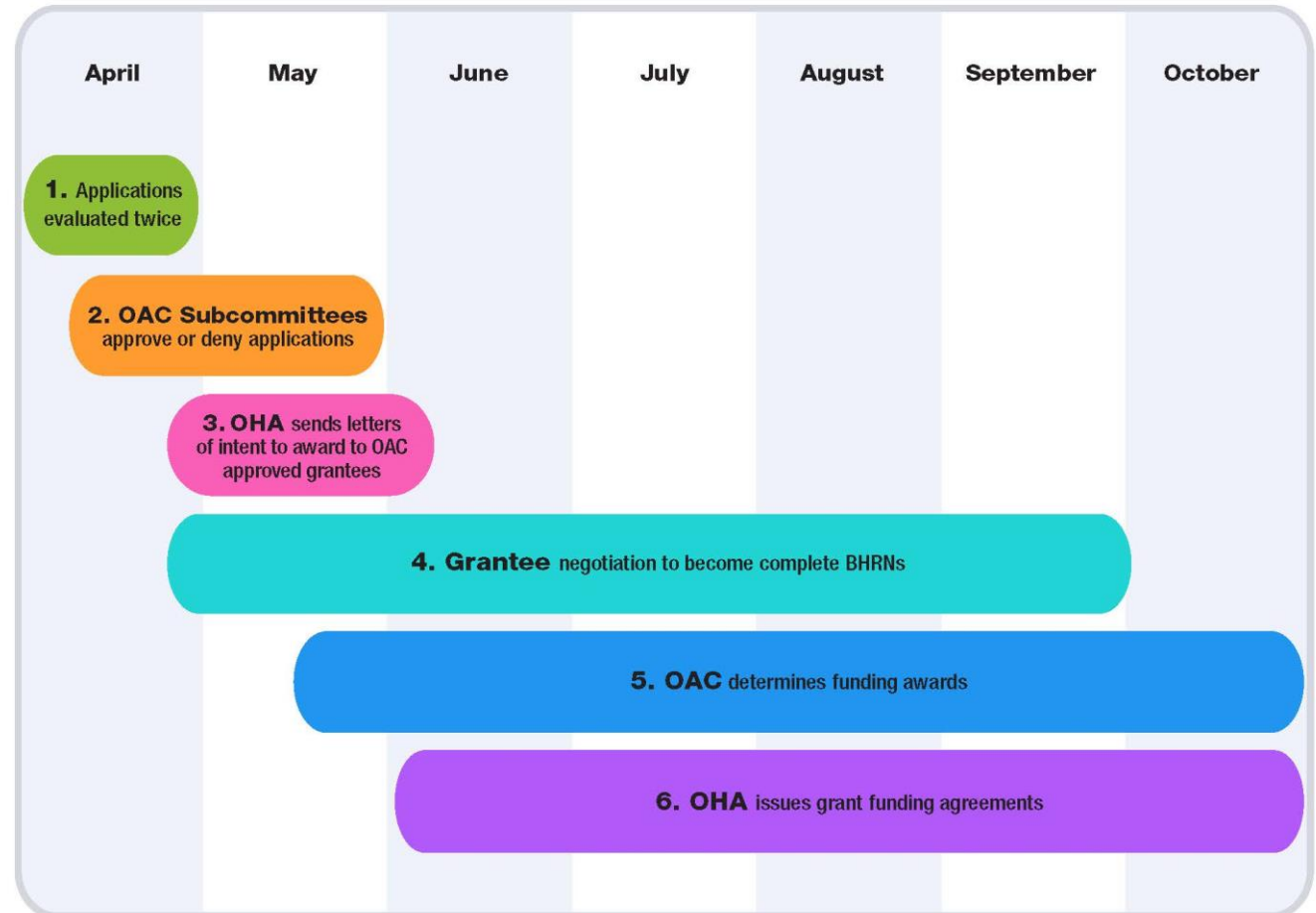

BHRN Application Approval Process

Please note each county region is moving through the steps as quickly as possible. We are working within each county based on set aside budgets. All applications will work through the process outlined below.

- 1 THROUGH THE END OF APRIL**
OAC and OHA review all 333 applications twice using an evaluation rubric.
- 2 MID APRIL THROUGH THE END OF MAY**
 As evaluation rubrics are completed for each county region the **OAC subcommittees** review rubrics to approve or deny applications. Two subcommittees meet concurrently; one focused on the tri-county region and the other on all other counties. A little less than half of all applications are based in the tri-county region.
- 3 END OF APRIL THROUGH FIRST WEEK OF JUNE**
 Upon OAC approval, **OHA sends letters of intent to award** to approved grantees.
- 4 END OF APRIL ONGOING THROUGH SEPTEMBER**
Grantees within a county must work to establish MOU amongst themselves to become a BHRN. OHA will work to facilitate that process, while also working with each entity to finalize grant agreements for particular scopes of work and funding.
- 5 MID MAY ONGOING THROUGH OCTOBER**
 After negotiating final terms of the Grant agreement **OAC** approves and the agreements are signed.
- 6 BEGINNING OF JUNE ONGOING THROUGH OCTOBER**
 Funding from **OHA** goes out as soon as both the agreements are signed and the necessary MOUs are in place.



M110 requires that a BHRN is only complete when it has all 7 required components working together to serve individuals.

The components:

- Screening and Comprehensive behavioral health needs assessment
- Individual Intervention planning, case management and connection to services
- Low Barrier Substance Use Disorder (SUD) Treatment
- Peer support, mentoring, and recovery services
- Housing Services
- Harm Reduction Intervention
- Supported Employment
