




LIQUOR MARKET DATA: CONSUMER VS. LICENSEE SALES TREND





LIQUOR MARKET DATA: VOLUME TREND






MARIJUANA MARKET DATA: DEMAND

ARTIFICIALLY DERIVED CANNABINOIDS

Beginning July 1, 2022:

- Hemp items sold to Oregon consumers on the general market are not permitted to contain any amount of artificially derived cannabinoids.
- This limitation includes both intoxicating and non-intoxicating artificially derived cannabinoids, including but not limited to:
 - CBN made synthetically from CBD or THC
 - Delta 8 made synthetically from CBD or THC
 - "THCO" (acetylated forms of THCs)
 - "HHC" (hexahydrocannabinol) or "HHCO"
- There is still a limited path for products containing non-intoxicating artificially derived cannabinoids to be sold in the OLCC-licensed adult use marijuana market.

HB 3000 & SB 1564 TASK FORCE

- Task Force on Cannabis-Derived Intoxicants and Illegal Cannabis Production
- Purpose: Consider the items listed in HB 3000 and SB 1564 to develop a report including final findings and recommendations for legislation, to the interim committee of the Legislative Assembly related to economic development no later than December 31, 2022
- Membership: Bipartisan and bicameral Task Force including representation from cities, counties, law enforcement, hemp growers, hemp handlers, marijuana licensees, OSU's Global Hemp Innovation Center, DA's, OSP, DOJ, BOLI, OWRD, ODA, OHA, and OLCC.



HB 4016: LICENSING MORATORIUM

 Effective January 1, 2022 – March 31, 2024 the OLCC may not accept new applications for producers, processors, wholesalers and retailers.

 Current licensees retain the right to sell their business or change the location of their business.

• A change of ownership (over 50%) or change of location requires pre-approval by the OLCC



UPCOMING RULEMAKING & COMPLIANCE

- License Reassignment Program
 - Implementing a program and administrative rules to issue licenses that have been surrendered, canceled or expired.
- Plant Batch Tagging
 - Modifying the requirement to physically tag each plant for tracking purposes, reducing monetary cost to licensees while still focusing on public health and safety.
- Laboratory Oversight
 - Utilizing in house and licensed laboratories for compliance checks continuing conversations about the need for a state reference lab.
