Legislative Funding 2021 and 2022

- HB 5006 2021 Regular Session
 - \$900,000 for Santiam Canyon
 Wildfire Recovery and Public Safety
 - \$975,000 for building and planning staff
 - Oregon Housing Community Services
 Wildfire Recovery Funding
- HB 5202 2022 Short Session
 - \$50,000,000 for the Mill City/Gates Sewer (HB 5006)
 - \$1,500,000 for Road and Bridge Repair





Gates Tiny Home Village

- Short-term housing for 16 units at the former Oak Park Motel
- Marion County Housing Authority will own and operate
- Tiny Homes have been ordered by OHCS and are scheduled to begin construction June 1, 2022
- Site development costs increased from \$1 M to \$2.5 M
- Seeking OHCS Wildfire Recovery Funding for site development
- Housing Stability Council Request on July 1, 2022 for Gates and N. Santiam Park site development costs





Santiam Park Tiny Homes

- Temporary housing for 16 households at the N. Santiam Park
- Marion County Housing Authority will own and operate the temporary housing on short term basis
- Environmental/ Due Diligence in process
- Seeking OHCS Wildfire Recovery Funding for site development





Santiam Canyon Wildfire Recovery

HB 5006

- City of Gates- Downtown Improvements \$600,000
 - Funding IGA received from DAS in May- in county approval process
- Lyons Ambulance Service- 2021 and 2022 Enhanced Summer Service \$300,000
- Building and Planning Staff \$975,000- will expend by end of 2022





North Santiam Sewer Project \$50,000,000

HB 5006 and HB 5202

- N. Santiam Wastewater Master plan completed 2021
- RFP for consultant team advertised Friday, May 20
- Proposals Due June 21
- \$40 M Mill City/Gates Sewer
- \$10 M Detroit/Idanha engineering and septic replacement
- Awaiting funding agreement from Business Oregon
- Interim Sewer Expansion Project \$7.5 M





Road and Bridge Repair \$1,500,000

HB 5202

- North Fork Road Guardrail Replacement -\$700K
 - Ready to bid
- North Fork Road Sign Replacement \$200K
 - In design
- Sinker Creek Bridge Replacement \$500K
 - In design
- Awaiting funding agreement from ODOT
