# **Military Matters: Key Issues**


The Defense-State Liaison Office works with Defense Department leaders and other stakeholders to choose 10 issues to focus on each year.

# **Military Spouse Licensure**

#### **Enhanced Military Spouse Licensure Portability**

States can streamline state licensing processes for relocating military spouses by providing them with a license within 30 days with minimal initial paperwork.

#### **Licensing Compacts**

States can facilitate the ability of professionals, including military spouses, to work across state lines by enacting occupational licensure interstate compacts.

#### Military Spouse Occupational Licensure Access

States can reduce the obstacles spouses experience when applying under state laws by posting easily accessible website content specific to military spouses.

#### Military Spouse Interstate License Recognition Options




Table below map lists states alphabetically.

## **Enhanced Military Spouse Licensure**

- A license within 30-days of application with minimal paperwork.
  - California: AB107 (2021)
  - Virginia: HB 967 (2020)
  - Colorado: HB 1326 (2020)
  - Maine: LD 374 (2021)
  - Pennsylvania: HB 1172 (2019)
  - Ohio: SB 7 (2020)



## **Compacts**



### Create a legally binding agreement between states

Similar to a contract, a compact establishes a formal, legal relationship among states to address common problems or promote a common agenda.



Promote cooperative action among states

Compacts can be leveraged for any issue where states have a need to coordinate. For example, existing compacts are used to reduce burdens for military families in transition, solve boundary disputes, manage shared natural resources, and build resilience to natural disasters



### Provide a widely recognized and durable policy solution

Every state is a member of at least one compact. There are over 250 active compacts in the U.S., and on average states are members of about 25.

- Audiology and Speech-Language-Hearing Interstate Compact: ASLP-IC (19 Member States)
- Nurse Licensure: NLC (37 Member States)
- Advanced Practice Registered Nurse: APRN (2 Member States)
- (On the horizon: Social Work, Barbering/Cosmetology, Massage Therapy)
