## **Composition**<sup>3</sup>

The board consists of three members; no more than two may be affiliated with the same political party. (HETTLE (N/A), **SERRES** (R) and **STEGER-BENTZ** (D).)

The Governor is required to consider the interests of labor, industry, and the public when making appointments, and the Governor designates the board's chair. The chair may appoint pro tempore members to serve for a maximum of 90 days with the Governor's approval. A majority of the board constitutes a quorum.

## **Duties**<sup>4</sup>

The board exists within the Employment Department to adjudicate appeals of decisions made by administrative law judges concerning eligibility for unemployment insurance benefits. The board must, upon receipt of a timely application for review, promptly affirm, modify, or set aside the decision of the administrative law judge and notify interested parties. The board may also:

- reconsider any previous decision of the board;
- hold sessions anyplace within the state; and
- administer oaths, and issue subpoenas for the production of persons and documents.
