ENERGY FACILITY SITING COUNCIL

Statement of Economic Interest²

Required.

Composition³

The council consists of representatives of the public. (**BEIER**, **CHOCKTOOT**, **CONDON**, **DOHERTY**, **GRAIL**, **HOWE** and **TRUITT**.)

Appointees are prohibited from serving if they have a conflict of interest. They cannot be a current or retired employee or director or consultant, or have anything other than an incidental pecuniary interest in entities operating or that want to operate an energy facility in Oregon, nor in manufacturers of any related equipment. They serve four-year terms and are eligible for reappointment, limited to two full terms, and may not accept employment with an owner or operator of an energy facility subject to council regulation for two years after the expiration of their term.

The council elects a chair and vice chair annually from among its members; a majority constitutes a quorum.

Duties⁴

The council implements energy policy and oversees the development of large-scale electric generating facilities, gas pipelines and high voltage transmission wires, among other projects. Siting a facility involves extensive review to meet standards and requirements applicable to the particular site. If approved, the council maintains regulatory jurisdiction over construction and operation. Council duties include:

- investigating and researching all aspects of site selection, independently or with others;
- encouraging voluntary cooperation among all stakeholders;
- advising and consulting with all interested groups and political subdivisions;
- consulting with the Water Resources Commission on its determinations to allocate water for hydroelectric development;
- designating local governing bodies as a special advisory groups where facility locations are proposed;
- forming an Electric and Magnetic Field Committee and reporting its findings to the legislature;
- applying legal standards to determinations regarding proposed energy facility sites; and
- reviewing programs to monitor environmental and ecological impacts of construction and operation of facilities.
