OREGON BOARD OF PHARMACY

The Governor has appointed the following individuals to the Oregon Board of Pharmacy, subject to Senate confirmation:¹

Statement of Economic Interest²

Not required.

Composition³

The board is comprised of nine members who are all Oregon residents. They select a president and vice president, meet at least once every three months, and serve four-year terms and at the pleasure of the Governor:

- Five are pharmacists (BEAMAN, DeBARMORE, DOYLE, LINARES, MURRAY and **PATEL**), licensed, in good standing, and practicing in Oregon for at least five years. (The Governor may select these appointees from a list of three to five nominees per vacancy, submitted by a task force convened by the Oregon State Pharmacy Association.)
- Two are pharmacy technicians (JOYCE and VIPPERMAN), licensed, in good standing, and practicing in Oregon for at least three years.
- Two are disinterested members of the public who are at least 18 years old (**HEMMINGS** and WATSON). (These appointees cannot have any current or former interest in the practice of pharmacy, nor any familial relationship with anyone who does.)

Duties⁴

The board regulates pharmacists, technicians, interns, a variety of drug outlets, and the manufacture and distribution of drugs and:

- oversees the practice of pharmacy through the administration of licensing, standards, and discipline;
- provides for the regulation of medications, drugs, devices, and related materials;
- prints and circulates changes in laws relating to pharmacy annually, including laws governing controlled substances, drugs and poisons, and any corresponding rules;
- appoints advisory committees; and
- determines fees to be collected for specified services.

The board may also:

- join professional organizations that promote improvements in the practice of pharmacy to protect public health and welfare;
- require surety bonds to guarantee the performance of duties of any officer or employee receiving and disbursing funds;
- receive and expend funds from parties other than the state under specified circumstances;
- assign to each drug outlet under its jurisdiction a uniform state number, coordinated where possible with all other states that adopt the same uniform numbering system;
- investigate and gather evidence concerning alleged violations of provisions under its jurisdiction;
- issue notices and subpoenas, and conduct hearings;
- employ persons to carry out its business; and
- require fingerprints from applicants and licensees in order to obtain a criminal background check.
