OREGON BOARD OF PSYCHOLOGY

The Governor has reappointed the following individual to the Oregon Board of Psychology, subject to Senate confirmation:¹

Statutory Authority

Statement of Economic Interest²

Not required.

Composition³

The board consists of nine members who are Oregon residents. Of those:

- six must have doctoral or master's degrees with a primary emphasis in psychology and must be licensed psychologists (or formerly licensed and retired from practice) (CHAN, GOY, JONES, MILLER, NISHI-STRATTNER and ZIEGLER); and
- three represent the public and may not be eligible for appointment otherwise, nor can they be the spouse, domestic partner, child, parent, or sibling of a licensed psychologist (HAGEN, JASANI and SCHERMER).

Appointees may be removed during their term if it is determined they do not meet the above criteria. Any professional organization that represents psychologists may submit a list of three to five nominees for each vacancy requiring a licensed psychologist. Members serve three-year terms and each must attest that they will faithfully and impartially discharge their duties. The board selects one member as chair and another as vice chair. A majority constitutes a quorum and they must meet at least once a year.

Duties⁴

The board oversees the practice of psychology and its responsibilities include:

- establishing standards for training, educational qualifications and a code of conduct for the ethical practice of psychology, including standards applicable to specialization;
- determining applicant qualifications to practice and administering examinations;
- formulating and enforcing continuing education requirements;
- obtaining fingerprints from specified persons to conduct a criminal records check;
- taking any action with respect to licensure, including issuance, suspension, revocation and restoration, and granting or denying renewals;
- issuing letters of reprimand, requiring periods of probation, imposing practice restrictions, requiring supervision, assessing civil penalties, and collecting fees;
- investigating alleged violations, issuing subpoenas for persons and documents and conducting hearings;
- maintaining records of all proceedings, and a register of all living psychologists it has licensed;
- instituting legal proceedings to enjoin the unlawful practice of psychology; and
- prescribing the duties of the Director of the Mental Health Regulatory Agency in consultation with the Oregon Board of Licensed Professional Counselors and Therapists.
