The Governor has appointed the following individual to the Oregon Growth Board, subject to Senate confirmation:

Statutory Authority

ORS 284.883 (2021)

Statement of Economic Interest²

Required.

Composition³

The board consists of up to 12 members:

- eight appointed by the Governor (JONES (CD1), MCGRANE and OLNEY (CD2), GREEN and PEET (CD3), PARSONS (CD4) and HUH and SCHULZ-OLIVER (CD5));
- two legislators that do not belong to the same political party, nonvoting (LIVELY and THOMSEN);
- the State Treasurer (READ); and
- the Director of the Oregon Business Development Department, or a designee, nonvoting (CHEANG).

Gubernatorial appointees must satisfy all of the following: there must be at least one representative from each of Oregon's five congressional districts, one with banking experience,

one with credit union operations experience, one with experience managing investments, one small business employer, and two at-large appointees.

Appointees serve four-year terms and are eligible for reappointment. The board selects a chair and a liaison with local governments. A majority of voting members constitutes a quorum.

Duties⁴

The board formulates and implements policies and procedures to encourage investment in and access to capital for businesses, and to increase resources available to governments that maintain financial services and supports that further economic development. Its duties include:

- making recommendations for the management of funds in the Oregon Growth Account and the Oregon Growth Fund;
- making recommendations to the Legislative Assembly to promote investments in the Oregon Growth Fund and the use of moneys in the Oregon Growth Account, including recommending legislation, to further economic development;
- reporting annually to legislative committees related to business and economic growth and board activities; and,
- reporting on the investment of moneys in the Oregon Growth Account that are necessary to fulfill audit, financial, investment, or other requirements applicable to the Education Stability Fund.

The board may also:

- enter into arrangements for the investment and management of moneys in the Oregon Growth Account and the Oregon Growth Fund;
- make, purchase, guarantee or hold loans for the purpose of earning returns for the Education Stability Fund;
- make, purchase, guarantee or hold grants and loans for the benefit of qualified businesses for the purpose of furthering economic development;
- qualify or certify businesses that invest in the Oregon Growth Account or the Oregon Growth Fund for any approved investment incentive;
- collaborate to provide financial services and support to businesses for the purpose of furthering economic development; and
- encourage and accept resources and donations for deposit into the Oregon Growth Account and the Oregon Growth Fund.
