# **Composition**<sup>3</sup>

The board's 11 members must reflect Oregon's geographic and cultural diversity and each member's background must demonstrate their commitment to the state's culture (DOWNES-LE GUIN, GOODWIN, **JOHNSON**, JONES-CENTENO, **KRAMER**, MORALES, PRICE, RENARD, SAMS, **VAN DYKE** and **YAMASAKI**).

The Speaker of the House of Representatives and the President of the Senate also appoint a legislator from their respective chamber to be a nonvoting advisory member (DOHERTY and HANSELL).

Members serve four-year terms. The board elects one of its voting members as chair and another as vice chair, a majority constitutes a quorum, and it meets at least once every three months.

#### **Duties**<sup>4</sup>

The board oversees management of the Trust for Cultural Development Account and provides direction to the Oregon Business Development Department with respect to its administration of the Arts Program and its use of funds. The board is also the custodian of any property received as trustee for the state.

#### The board may:

- adopt rules necessary to administer the Trust for Cultural Development Account;
- solicit and accept money, securities, or other property of any kind; and
- sell or exchange property as it determines appropriate.
