The Governor has reappointed the following individual to the Oregon Health and Science University (OHSU) Board of Directors, subject to Senate confirmation:

Statement of Economic Interest²

Required.

Composition³

The board consists of nine members:

- seven representatives experienced in areas related to the university's missions or that
 are important to the success of the university (BEYER, CARLSON, KING, MONFRIES,
 PAULSON, STEWARD and ZIKA);
- · one student enrolled at the university (BRAR); and
- the president of the university (JACOBS).

The board nominates a slate of candidates for consideration whenever there is a vacancy, and a recognized entity of student government submits a list of student nominees. No members except the president may be employed by OHSU. The student appointee serves two years and other appointees serve four, and all are eligible for reappointment for one additional term. Members may be removed for cause, after notice and public hearing, but no more than three within a period of four years, unless it is for corrupt conduct in office.

The board selects its chair and vice chair, adopts bylaws to define a quorum and when a quorum is necessary, and meets at least once every three months.

Duties⁴

The board governs OHSU as it carries-out a number of public purposes and missions including:

- providing high-quality educational programs appropriate for a health and science university;
- conducting research in health care, engineering, biomedical sciences and general sciences;
- providing inpatient and outpatient clinical care and health care delivery systems;
- providing outreach programs in education, research, and health care;
- serving as a resource for health care providers; and
- continuing a commitment to provide health care to underserved patient populations.

The board also:

- appoints and supervises the university president;
- prescribes requirements for a venture grant program and the criteria applicants must meet in order to receive funds; and
- may appoint and employ personnel, enter into specified agreements and partnerships, acquire and control use or disposition of property of any kind, sue and be sued, encourage gifts and donations, borrow money, purchase insurance or operate a self-insurance program, develop academic programs, manage any program or other unit of operation, charge for enrollment, collect fees, regulate vehicle traffic and parking, and establish a police department.
