OREGON STATE VETERINARY MEDICAL EXAMINING BOARD

The Governor has reappointed the following individual to the Oregon State Veterinary Medical Examining Board, subject to Senate confirmation:

Statutory Authority

ORS 686.210 (2021).

Statement of Economic Interest²

Not required.

Composition³

The board consists of eight Oregon residents:

- five must be licensed to practice veterinary medicine, surgery, and dentistry in this state (DAVIS, DEBESS, HAMILTON, LAMB and WILSON);
- one must be a certified veterinary technician (MAIR WILLIAMSON); and
- two must be members of the public who are not otherwise eligible for appointment to the board nor have any familial relationship with a person licensed by the board (PATE and TAYLOR).

Members serve four-year terms. Statewide professional associations for veterinarians and for veterinary technicians may suggest nominees for public positions on the board and for veterinarian and veterinary technician positions, respectively.

The board elects its president and in the president's absence, the board elects a temporary chair. A majority constitutes a quorum.

Duties⁴

The board is responsible for authorizing and regulating the practice of veterinary medicine. The board must:

- administer licensing, certification, and registration for veterinarians, veterinary assistants, and veterinary facilities;
- investigate complaints; and
- adopt rules for the administration of statutes assigned to the board.

The board may:

- specify circumstances by rule, whereby unlicensed persons may administer vaccinations, anesthetics, or otherwise assist in the practice of veterinary medicine;
- discipline an authorized practitioner for unprofessional or dishonorable conduct with the consent of five members;
- discipline an authorized practitioner for certain deceitful conduct, or who is unable to practice safely or competently based on a variety of determinations;
- refuse to issue or renew authorization to practice based on a finding of unprofessional or dishonorable conduct;
- undertake a variety of disciplinary actions if necessary, including the revocation or suspension of an individual's authorization to practice, imposing probation or practice limitations, issuing reprimands, and assessing costs or civil penalties;
- impose fines for administrative violations that do not create a risk of harm to the public, as established by rule;
- appoint committees of not less than three licensed, practicing veterinarians to investigate violations of provisions administered by the board;
- adopt rules necessary for the administration of statutes assigned to the board;
- employ an investigator or other personnel when necessary;
- adopt and impose fees for specific activities;
- receive evidence; take depositions; compel appearances and documents; require answers to interrogatories; inspect premises; and order applicants or authorized practitioners to undergo specified examinations;
- enjoin any practice determined to be in violation of laws administered by the board;
- adopt rules governing veterinary facility removal of domestic animals; and
- establish a certified Euthanasia Task Force and assess application and certification fees against certified euthanasia technicians and their employers.
