# Oversight and Accountability Council (OAC)

- Oversees and implements grant funding and Behavioral Health Resource Networks (BHRNs)
- First in the nation for this approach
  - Has guided and informed efforts by other states and countries
- Council members come from a diverse background
  - A majority have lived experience

# Key Values

- All treatment should be low barrier and have harm reduction philosophy
  - Treatment is what you want, when you want it
- Prioritize culturally specific, culturally responsive, and inclusive programs
- Housing is Health
  - The council has prioritizing both supportive housing (low barrier housing first) and recovery housing (sober and drug free housing)
- Includes reducing drug-related harm and supporting services for individuals who are actively using drugs, including those who are not seeking treatment or recovery

# Accomplishments

- Over 140 meetings over the past 19 month
  - Most members have full time employment and outside responsibilities, so this represents a significant time investment by a truly dedicated group
- Funding and policy decisions informed by discussions with agencies, providers and consumers
- Funded over 170 entities with over 240 grant agreements across the State and Tribal Nations
  - Many organizations funded had limited or no prior relationship with OHA
- Established a community grant process and BHRN funding criteria resulting in the awards of nearly \$292.5M services and supports for addiction treatment
- Approved the final BHRN on 8/31/22
  - A total number of 44 BHRNs
  - Offering community driven and culturally specific drug treatment and recovery services
  - Several counties being served by more than one network

### Measure 110 BHRN Approval Progress

This map shows counties where the full Oversight and Accountability Council (OAC) has approved all of the entities within the Behavioral Health Resource Network (BHRN) (in **ORANGE**). Entities within **BLUE** counties have already been selected by an OAC subcommittee to receive a letter of intent to award and are in the negotiation process. Once negotiations are complete, the BHRN will be voted on by the full OAC. This map will be updated as more BHRNs are approved during the weekly OAC meetings.

# Next Steps BRHN Grant Monitoring and Compliance

With all the BRHNs now funded, the OAC and OHA now begin the important next step of monitoring the grantees compliance through the previously established processes including:

- Requiring grantees to report service data and fiscal data on a periodic basis
- Requiring grantees to submit their service delivery policies and procedures
- Performance audits and reviews by Oregon's Secretary of State
- OHA certification of community health workers, peer wellness specialists and peer support specialists working within the BHRNS
- OHA certification of outpatient substance use disorders treatment and recovery programs.
- A complaint intake process
