Chair Evans and Members of the Special Committee:

In addition to my verbal remarks for today's hearing, I wanted you to be aware of a bit more detail on the overall fiscal end with respect to the Holiday Farm Fire recovery efforts. With the exception of commercial insurance pay-outs, for which Lane County does not have specific data, the total amount of dollars <u>received</u> into Lane County for recovery efforts from state, federal, philanthropy, and local investments is approximately \$53.5M to date. Of those total dollars, approximately \$19M is dedicated for watershed restoration, \$14M is for infrastructure, \$12M for individual assistance, \$6M for housing, \$2M for healthcare, and \$1M for recovery coordination.

Lane County is now working through recovery efforts with the following state agencies; OBDD, DLCD, DCBS, ODOE, ODOT, OHCS, OEM/DEM, DAS, DEQ, DHS, the Governor's Office, and Oregon Solutions. That is over ten state agencies. Each agency does have its own culture and willingness to collaborate, and its own policies and procedures. Each seems genuinely wanting to help our communities recover, but my observation is that going forward, Oregon clearly has to decide who is in charge of recovery. Each agency has administrative overhead associated with each appropriation, and some are must faster at getting dollars delivered than others. For future recovery efforts, I hope we can figure out how to streamline recovery under one, or at most two agencies.

While \$53M is an enormous amount of money, we do anticipate at least that much need as we continue though future Holiday Farm recovery efforts. I have attached to this letter a separate document that outlines some of the priority projects and estimated costs (some yet to be determined), that we are committed to complete.
