## HOME CARE COMMISSION

The Governor has appointed the following individuals to the Home Care Commission, subject to Senate confirmation:<sup>1</sup>

### **New Appointment**

Mark King of Portland

#### **Statutory Authority**

ORS 410.602 (2021).

### Statement of Economic Interest<sup>2</sup>

Not required.

## **Composition**<sup>3</sup>

The commission consists of nine members:

- five current or former consumers of home care services for the elderly or persons with disabilities (GUEDON, JOHNSON, KING, MAYFIELD, VOLPE and WENTZELL);
- one representative of the Governor's Commission on Senior Services (MCEWEN);
- one representative of the Department of Human Services (JOHNSON);
- one representative of the Oregon Disabilities Commission; and
- one representative of the Oregon Association of Area Agencies on Aging and Disabilities (MOORE).

Terms are three years, limited to three consecutive terms. The Governor annually selects the chair and the Department of Human Services appoints one of its employees as the commission's executive director, subject to the commission's approval.

### **Duties**<sup>4</sup>

The commission's duties, in collaboration with the Department of Human Services, include:

- ensuring the quality of home care services;
- establishing qualifications for home care workers and personal support workers;

- maintaining a statewide registry of qualified workers;
- providing training opportunities for workers and the consumers who employ them;
- serving as the "employer of record" for purposes of collective bargaining for homecare and personal support workers who receive payments from public funds;
- providing routine, emergency and respite home care worker referrals;
- entering into agreements with public and private organizations and individuals to obtain or develop training materials and curriculum or other services; and
- working cooperatively with area agencies and other state and local entities.
