Composition³

The committee consists of 15 members representing:

- insurers (ANDERSON and HOPPER);
- insurance producers (BOUTWELL, GALLINAT and SUKHEENAI);
- navigators, in-person assisters, application counselors, and other individuals with experience in facilitating enrollment in qualified health plans (MOORE, SHIRAHAMA, SORENSEN and TEMPERLY);
- health care providers (HARMON and TARAB);
- the business community (KEMPER);
- consumer advocacy groups (GUARINO and JONATHAN);
- enrollees in health benefit plans (KEMPER);
- state agencies that administer the medical assistance program (VACANT); and
- the Director of the Oregon Health Authority or a designee (STOLFI).

Duties⁴

The committee advises the Oregon Health Policy Board on the development and implementation of policies and procedures governing administration of the state's health insurance exchange, including:

- the assessment amount imposed on insurers;
- implementation of a Small Business Health Options Program;

- processes to authorize each insurance producer to act on behalf of all insurers offering health benefit plans through the exchange;
- the affordability of plans offered by employers;
- the affordability of health benefit plans generally, offered through the exchange;
- strategies to reach out to minority and low-income communities;
- · soliciting consumer feedback; and
- reporting findings and recommendations annually on the adequacy of assessments
 for reserve programs, operation of the Small Business Health Options Program, the
 number of qualified health plans offered through the exchange, the demographics of
 individuals enrolled in qualified health plans, advance premium tax credits provided
 to enrollees in qualified health plans, and feedback received about satisfaction with
 the exchange and with qualified health plans offered through the exchange.
