OREGON BOARD OF LICENSED PROFESSIONAL COUNSELORS AND THERAPISTS

The Governor has appointed the following individual to the Oregon Board of Licensed Professional Counselors and Therapists, subject to Senate confirmation:¹

Statement of Economic Interest²

Not required.

Composition³

The board consists of eight state residents:

- three licensed professional counselors (HARMAN, PARRAMON MORODO and REDEAU);
- two licensed marriage and family therapists (**HENRY** and REESER);
- one faculty member from an in-state school offering a program of study to become a professional counselor or marriage and family therapist (NI); and
- two representing the public who have an interest in the fields of professional counseling and marriage and family therapy but who are not licensed nor or the spouse, domestic partner, child, parent, or sibling of a licensee (HATCH and VACANT).

Appointees serve three-year terms and those who are required to be licensed may be selected from a list of three to five nominees per vacancy submitted by any professional organization representing licensees. An appointee must be removed immediately if, during their term:

- they are no longer a resident; or
- they are no longer licensed (unless they retired, and their license was in good standing at the time of appointment); or
- they have missed three consecutive board meetings, unexcused.

They meet at least once a year and select a chair and vice chair at the first meeting of each year. A majority constitutes a quorum.

Duties⁴

The board regulates the practice of qualified professional counselors and marriage and family therapists. Its duties include:

- adopting rules;
- adopting a code of ethics and forming standards committees to establish, examine, test and determine the qualifications of applicants to practice professional counseling or marriage and family therapy, including standards and requirements for continuing education and supervision;
- issuing licenses to qualified applicants, including reciprocal licenses;
- maintaining a register of all current licensed professional counselors and marriage and family therapists and making a directory available to the public annually;
- adopting and imposing administrative fees;
- prescribing the duties of the Mental Health Regulatory Agency in consultation with the Oregon Board of Psychology;
- prescribing the duties and fixing the compensation of board employees;
- reviewing complaints and conducting investigations and hearings;
- seeking injunctions for specified violations, assessing civil penalties; and
- reporting to the Legislative Assembly.
