#### **Statutory Authority**

#### Statement of Economic Interest<sup>2</sup>

### **Composition**<sup>3</sup>

The board includes seven members that may serve recurring three-year terms:

- five licensed chiropractors in practice for at least five years prior to appointment (ALLEY, BARANICK, FULLER, KNECHT and WAGGONER); and
- two members of the public who are not chiropractors (or the spouse, domestic partner, child, parent, or sibling of a chiropractor) (SCHMIDT and TAYLOR).

Members are selected from a list of three to five nominees submitted by any professional organization representing chiropractors. They may be removed immediately if they are not Oregon residents, if they are not licensed, or if they have three consecutive unexcused absences from meetings.

The board elects its president, vice president and a secretary/treasurer annually, and they meet each January and July.

#### **Duties**<sup>4</sup>

The board regulates chiropractic practice. Its duties include:

- adopting rules and prescribing license requirements;
- prescribing minimum and continuing educational requirements;
- establishing standards and tests to determine eligibility for licensure, specialty certification, certification of chiropractic assistants, and for the use of ancillary personnel;
- reviewing applications for licensure and administering examinations;
- accepting or approving schools, colleges and institutions, residencies, internships and other trainings;
- exercising general supervision and forming peer review committees to evaluate complaints against chiropractic physicians;
- conducting investigations and hearings with respect to complaints and imposing penalties including injunctions, probation, license suspension, denial or revocation, and assessing costs; and
- enter into agreements to make its personnel and facilities available to other regulatory entities or other bodies interested in the development and improvement of chiropractic practice
