Statement of Economic Interest²

Not required.

Composition³

The board consists of 11 state residents with no financial or fiduciary interest in residential facilities, long term care facilities, or service providers, nor any involvement with their licensing or certification, including:

- seven gubernatorial appointees (ALLEN, FRIEDMAN, GILES, GLAUS, HINES, KAO, SCHREIBER and WILLIAMS);
- one appointee of the Speaker of the House of Representatives (JANSSEN);
- one appointee of the President of the Senate (EDWARDS);
- one appointee of the House Republican leader (TERRY); and
- one appointee of the Senate Republican leader (MOWRY).

The Governor selects three appointees, one each from a list of four names submitted by organizations for seniors, organizations for persons with mental illness, and the Oregon Council on Developmental Disabilities. Two of the four remaining gubernatorial appointees have expertise in the provision of guardianship, conservatorship and other fiduciary services for persons with inadequate resources.

Appointees serve four-year terms. The board selects its chair and vice chair and sets their terms and duties. They meet at least once per month and confer with the Long Term Care Ombudsman.

Duties⁴

The Long-Term Care Ombudsman program serves long-term care facility residents through complaint investigation, resolution, and advocacy for improvements in care. The board monitors the program, confers with the Long Term Care Obudsman, and advises the Governor and the Legislative Assembly. It also nominates three persons to fill Long Term Care Ombudsman position vacancies, after interviews and according to prescribed criteria. The board may also review any action by the Ombudsman appealable to the board and, if the board disagrees with the action of the Ombudsman, remand the matter with instructions for resolution.
