Statement of Economic Interest²

Not required.

Composition³

The board consists of seven Oregon residents who serve three-year terms:

- four active, licensed denturists (CHAPMAN, FARRIS, **SMITH** and YOUNG);
- one active Oregon-licensed dentist (**BORROMEIO**); and
- two representatives of the public who do not possess the professional qualifications of other members, who are not a family member of an actively licensed denturist or dentist (REES and VACANT).

Denturist appointees may be selected from a list of three to five nominees for each vacancy, submitted by a professional organization representing denturists. The board meets at least once a year and elects its chair annually.

Duties⁴

The board establishes policies and criteria to assess the quality of the practice of denture technology based on standards subject to the approval of the Oregon Health Authority's Health Licensing Office.
