STATE MORTUARY AND CEMETERY BOARD

The Governor has appointed the following individual to the State Mortuary and Cemetery Board, subject to Senate confirmation.1

Statutory Authority

ORS 692.300 (2021).

Statement of Economic Interest²

Not required.

Composition³

The board consists of 11 Oregon residents that include:

- one funeral service practitioner (GASKILL);
- two representing an immediate disposition company or a licensed funeral establishment, one of whom is a licensed embalmer (BONE and LOVELAND);
- three cemetery representatives: one for-profit cemetery (MCKENZIE-TUCKER), one nonprofit cemetery (FELTON), and owned or operated by a local government (PORTER);
- one representing a crematorium or other facility for final disposition that is not a cemetery (COLLINS); and
- four representatives of the public, one of whom belongs to a recognized senior citizen organization (BRITTON, CANIZARES, HARRIS and PACHECO).

For vacancies other than public representatives, appointments may be made from lists of three to five nominees per vacancy submitted by professional organizations that represent individuals or facilities regulated by the board. Appointees serve four-year terms; the board elects its president and a secretary for one year; and they meet at least twice a year.

Duties⁴

The board regulates death care facilities and practitioners. Its duties include:

- conducting examinations and issuing licenses;
- establishing and collecting certain fees;
- receiving complaints, conducting investigations and hearings, and taking disciplinary actions;
- inspecting the premises and records of regulated entities and any other locations where human remains may be prior to final disposition, at least once every two years;
- employing personnel to perform inspections and undertake enforcement activities; and
- maintaining a list of institutions that receive deceased persons for education or research purposes.
