## **Composition**<sup>3</sup>

The board consists of five commissioners, all US citizens residing in the jurisdiction for at least a year immediately preceding appointment (EDWARDS, FARM, GARCIA, HANSON, STEVENS and VIKSNEHILL). The Governor designates its president and the president designates other officers. Members serve four-year terms.

#### **Duties**<sup>4</sup>

The board establishes policies for governance of the port and reports to the legislature biennially. The board may also own, operate, repair, and maintain the Coos Bay rail link; create an executive committee comprised of all commissioners; borrow money, issue bonds; and annex areas for the port and the Coos Bay rail link.
