## **SUMMARY**

Requires separate calculation of virtual public charter school ADMw if school district that sponsors virtual public charter school had decrease in ADMw as compared to previous school year.

Applies to State School Fund distributions commencing with 2022-2023 distributions.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

- 2 Relating to calculations of district extended ADMw; creating new provisions;
- amending ORS 338.155; and declaring an emergency.
- 4 Be It Enacted by the People of the State of Oregon:
- 5 **SECTION 1.** ORS 338.155 is amended to read:
- 6 338.155. (1)(a) Students of a public charter school shall be considered to
- 7 be residents of the school district in which the public charter school is lo-
- 8 cated for purposes of distribution of the State School Fund.
- 9 (b) All amounts to be distributed from the State School Fund for public
- 10 charter schools shall first be distributed to the school district in which the
- 11 public charter school is located.
- 12 (c) For the purpose of determining the amounts to be distributed to a
- 13 school district from the State School Fund for a public charter school, the
- 14 district extended ADMw described in ORS 327.013 shall be calculated:
- (A) Except as provided by subparagraph (B) or (C) of this paragraph, as
- 16 though the students enrolled at a public charter school are students enrolled
- 17 at the public schools of the school district in which the public charter school
- 18 is located.

- 1 (B) By not including any portion of the ADM of the public charter school 2 for the previous school year if the public charter school ceased to operate 3 because of dissolution or closure or because of termination or nonrenewal 4 of a charter.
- (C) By calculating the current school year's ADMw separately for a virtual public charter school and for the school district if the school district, without consideration of the ADM of the virtual public charter school, had a decrease in ADM or ADMw compared to the previous school year.
- 9 (2) A school district shall contractually establish, with any public charter 10 school that is sponsored by the board of the school district, payment for 11 provision of educational services to the public charter school's students. The 12 payment shall equal an amount per weighted average daily membership 13 (ADMw) of the public charter school that is at least equal to:
- 14 (a) Eighty percent of the amount of the school district's General Purpose 15 Grant per ADMw as calculated under ORS 327.013 for students who are en-16 rolled in kindergarten through grade eight; and
- 17 (b) Ninety-five percent of the amount of the school district's General 18 Purpose Grant per ADMw as calculated under ORS 327.013 for students who 19 are enrolled in grades 9 through 12.
- (3) A school district shall contractually establish, with any public charter school that is sponsored by the State Board of Education and that is within the boundaries of the school district, payment for provision of educational services to the public charter school's students. The payment shall equal an amount per weighted average daily membership (ADMw) of the public charter school that is at least equal to:
- 26 (a) Ninety percent of the amount of the school district's General Purpose 27 Grant per ADMw as calculated under ORS 327.013 for students who are en-28 rolled in kindergarten through grade eight; and
- (b) Ninety-five percent of the amount of the school district's General Purpose Grant per ADMw as calculated under ORS 327.013 for students who are enrolled in grades 9 through 12.

- (4) The estimated amount of each school district's General Purpose Grant per ADMw shall be determined each year by the Department of Education and made available to all school districts.
- (5) The school district in which the public charter school is located shall transfer an amount per weighted average daily membership (ADMw) of the public charter school that is equal to 50 percent of the amount of the school district's General Purpose Grant per ADMw as calculated under ORS 327.013 that is not paid to the public charter school through a contract created pursuant to subsection (3) of this section to the Department of Education.
- 10 (6) The department may use any moneys received under this section for activities related to public charter schools.
- 12 (7) A school district and a public charter school may negotiate to estab-13 lish a payment for the provision of educational services to the public charter 14 school's students that is more than the minimum amounts specified in sub-15 section (2) or (3) of this section.
- 16 (8) A school district shall send payment to a public charter school based 17 on a contract negotiated under this section within 10 days after receiving 18 payments from the State School Fund pursuant to ORS 327.095.
- (9)(a) A public charter school may apply for any grant that is available to school districts or nonchartered public schools from the Department of Education. The department shall consider the application of the public charter school in the same manner as an application from a school district or nonchartered public school.
- 24 (b) The department shall award any grant that is available to school dis-25 tricts based solely on the weighted average daily membership (ADMw) of the 26 school district directly to the public charter school. This paragraph does not 27 apply to any grant from the State School Fund.
- 28 <u>SECTION 2.</u> The amendments to ORS 338.155 by section 1 of this 29 **2023** Act apply to State School Fund distributions commencing with 30 the 2022-2023 distributions.
- 31 SECTION 3. This 2023 Act being necessary for the immediate pres-
