Dear Committee members, below you will find a list of LCs that are planned for introduction during legislative days.

LC Number	Dated	Summary
179	10/19/22	Modifies provisions relating to special motions to strike.
279	11/15/22	Modifies statutes to allow for non-attorney associate members of the Oregon State Bar to practice law in certain scope of practice.
283	7/26/22	Provides procedure by which party can present offer of judgment in arbitration proceeding.
290	7/25/22	Modifies eligibility for simple estate affidavit to include estate of decedent dying testate if value of specific bequests does not exceed specified amount and residual beneficiary is decedent's inter vivos trust
292	7/19/22	Modifies number of weeks notice to interested persons in decedent's estate must be published.
372	8/29/22	Increases civil penalty to \$1 mil for violation of antitrust laws, repeals venue limitation, and allows prosecution of both criminal prosecution and civil penalties. Increases criminal penalties for conspiring to restrain or monopolize trade to commerce to \$250k fine and 10 years.

566	8/19/22	Modifies damages and penalties awarded for action for false claims. Extends SOL from 3 years to 5 years. Provides for confidentiality and permissible disclosures of materials relating to false claims.
613	9/27/22	Directs court to take into consideration child's preferences when making best interests determination for purposes of child custody determination.
692	10/6/22	Makes non-substantive and technical changes in Oregon law.
870	10/5/22	Provides that requirement that certain hearsay statements of unavailable witnesses concerning acts of abuse must be supported by corroborative evidence applies in juvenile delinquency proceedings.
923	10/22/22	Provides that person who contracts with public body to provide services for purposes of community restoration or to restore fitness to proceed is state officer, employee or agent for purposes of indemnification under Oregon Tort Claims Act under certain circumstances
1292	11/9/22	Provides that person sentenced to mandatory minimum sentence under Ballot Measure 11 (1994), for crime other than murder, who has not been previously sentenced under measure is eligible for reduction in sentence for appropriate institutional behavior and participation in certain programming unless otherwise ordered by court for substantial and compelling reasons. Creates procedure by which sentencing court may enter supplemental judgment authorizing persons currently serving sentences under Ballot Measure, not previously sentenced under measure, to be eligible for reduction in sentence for appropriate institutional behavior and participation in certain programming
1792	10/20/22	Omnibus bill relating to PCR for non-unanimous juries; Discovery Reimbursement; Presentence reports
1972	12/2/22	Transfers Public Defense Services Commission from judicial to executive branch. Modifies appointment and removal process for and qualifications of commission members.
1987	12/1/22	Placeholder pending further research.

2048	12/5/22	Modifies appointment and removal process for members of Public Defense Services Commission. Modifies powers and duties of commission. Directs commission to establish and implement specified minimum standards, policies, guidelines and procedures. Directs justice and municipal courts to report every two years to commission and interim committees of Legislative Assembly related to judiciary concerning appointment of counsel in court. Declares emergency effective on passage.
2229	11/2/22	Professional licensing board restricted from disqualifying applicants with criminal histories not substantially relating to specific duties requiring license. Creates pre-application determination process relating to same. Limits use of juvenile records in in certain employment, agency, or licensing decisions. Finding that youth is within jurisdiction of juvenile court does not disqualify person from holding public office nor from pursuing or engaging in lawful activity or profession. Certain juvenile crime records disclosable to crime victims, law enforcement, and other specified entities.
2250	12/1/22	Requires owner of real property where site of unlawful manufacture of marijuana or unlawful production of marijuana is located to clean up waste from site upon receipt of notification from law enforcement agency. Provides that failure to timely complete cleanup is public nuisance and authorizes local government to take certain actions to abate it, including filing claim of lien against real property. Prohibits use of water at location not licensed or registered for growing of cannabis. Allows Water Resources Commission to impose civil penalty for violation. Allows use of mobile tracking device and pen register and law enforcement interception of oral communications in specified circumstances. Increases penalties for possession or manufacture of marijuana in specified quantities. Creates crimes of marijuana offense involving reckless unlawful conduct and marijuana offense involving knowing unlawful conduct.
2289	10/25/22	Provides that district attorneys and deputy district attorneys qualify as police officers under Public Employees Retirement System.
2304	11/16/22	Authorizes Public Defense Services Commission to award grants for purpose of carrying out duties of commission.
3022	11/16/22	Directs district attorney to calculate cost of creating and providing copies of discovery material to defendant with

court-appointed counsel and to submit request for reimbursement to Oregon Department of Administrative Services. Appropriates moneys to department for reimbursement of discovery costs.

3245	12/5/22	Provides that members of Public Defense Services Commission are entitled to per diem compensation for service on commission. Removes designation of fees and expenses of appointed counsel in criminal case that require preauthorization as “nonroutine” expenses. Provides that such fees and expenses are those that require preauthorization under policy of commission
