276	8/15/22	Allows public member of board of governors of Oregon State Bar to be elected as president or president-elect of board.
282	7/25/22	Modifies provisions relating to mailing of notice of appeal
284	9/8/22	Redesignates Uniform Fraudulent Transfer Act as Uniform Voidable Transactions Act. Conforms provisions relating to covered transactions, burdens of proof and choice of law.
288	7/7/22	Modifies execution formalities for appointment of person to make decisions concerning disposition of remains and for declaration for mental health treatment

2107	11/18/22	Modifies definition of "oral or anal sexual intercourse" for purposes of sex crimes. Expands crime of using a child in a display of sexually explicit conduct to include when person knowingly creates visual recording of sexually explicit conduct involving child. Punishes by maximum of 20 years' imprisonment, \$375,000 fine, or both. Modifies crimes of unlawful sexual penetration in the first and second degrees. Provides that any object may be used in commission of offense.
2121	11/28/22	Permits county juvenile department to provide preventive services to certain persons under 12 years of age. Modifies high-risk juvenile crime prevention plan targeted population to include certain persons under 12 years of age. Creates minimum age for juvenile court jurisdiction in delinquency proceedings. Appropriates moneys to Youth Development Division for purposes of providing preventive services to certain persons under 12 years of age.
2195	11/23/22	Establishes Juvenile Justice Advisory Commission within Oregon Criminal Justice Commission. Specifies membership of Juvenile Justice Advisory Commission. Requires commission to conduct policy analysis based on specified criteria and make recommendations to Legislative Assembly relating to juvenile justice system.
2249	11/18/22	Provides that venue is proper in county in which victim resides for specified offenses, and in any county in which one offense was committed when defendant is charged with committing two or more property offenses against same victim within 180 days. Authorizes reimbursement for cleaning expenses related to death of person as part of crime victims' compensation program. Expands crime of coercion to include using physical force to cause person to move, or prevent person from moving, from one place to another. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both.
2256	11/15/22	Expands offense to include any substance that, when taken into human body, can impair the ability of person to operate vehicle safely. Defines "intoxicant." Permits conviction even if accusatory instrument does not plead fact that person was under influence of controlled substance or inhalant. Provides that once individual is convicted of felony DUII, any subsequent episode is a Class C
