(3:50 PM) Directs State Department of Agriculture to establish grant program to fund upgrades to establishments expected to operate under program of state meat inspection.

HB 2786 ** **Subsequent Referral(s) to Ways and Means
(4:05 PM) Directs State Department of Agriculture to study barriers to family-scale meat production and ways to promote family-scale meat production, and recommend legislative or regulatory avenues to remove identified barriers and promote family-scale meat production.

HB 2068

(4:35 PM) Makes provisions regarding issuance and use of landowner preference tags for hunting wildlife permanent.

HB 2069 ** **Subsequent Referral(s) to Ways and Means (4:35 PM) Establishes Sage Grouse Mitigation Program In-Lieu Fee Fund.
