**Subsequent Referral(s) to Ways and Means

Allows State Fish and Wildlife Commission to charge fees for hunting, angling and shellfish licenses, tags and permits that are less than amount established in statutory fee schedule.

- HB 2069 ** **Subsequent Referral(s) to Ways and Means
Establishes Sage Grouse Mitigation Program In-Lieu Fee Fund.
- HB 2785 ** **Subsequent Referral(s) to Ways and Means
Directs State Department of Agriculture to establish grant program to fund upgrades to establishments expected to operate under program of state meat inspection.
- HB 2786 ** **Subsequent Referral(s) to Ways and Means
Directs State Department of Agriculture to study barriers to family-scale meat production and ways to promote family-scale meat production, and recommend legislative or regulatory avenues to remove identified barriers and promote family-scale meat production.

Note change: Work sessions for HB 2067, HB 2069, HB 2785, and HB 2786 have been added.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
