Public Hearing

HB 2844

(3:20 pm) Provides, for purposes of certain statutes relating to taking of predatory animals, that terms "predatory animal" and "rodent" do not include beavers.

- HB 3114 ** **Subsequent Referral(s) to Ways and Means
 (3:40 pm) Appropriates moneys from General Fund to Oregon Ocean Science Trust, State Department of Fish and Wildlife and Higher Education Coordinating Commission in certain amounts for certain purposes related to ocean chemistry.
- HB 3150 ** **Subsequent Referral(s) to Ways and Means
 (3:55 pm) Requires State Department of Fish and Wildlife to establish and operate fish incubation box program for rearing of salmonids on suitable waterways in coastal areas of southern Oregon.

HB 2691

(4:10 pm) Directs State Department of Energy to conduct study to identify techniques to increase visibility to birds of rotor blades on wind energy facilities and evaluate suitability of techniques for use in Oregon.

Work Session

HB 2032

Establishes that Department of State Lands or State Department of Agriculture rules implementing traditionally maintained channels program may provide for implementation on region-by-region basis.

HB 2033

Authorizes State Department of Agriculture to deputize veterinary technicians to assist department in carrying out its duties.

HB 2171 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Conservation and Recreation Advisory Committee to consult with Office of Outdoor Recreation when making recommendations regarding use of Oregon Conservation and Recreation Fund moneys.

HB 2549

Requires agencies to send copies of reports on public access sites to State Marine Board and for board to make reports public, including by hosting map of reported sites on website.

HB 2531

Adds State Forestry Department, Department of Transportation and State Department of Fish and Wildlife as consulting agencies for state pollinator health outreach and education plan.

HB 2728

Prohibits person from conducting or participating in contest, competition, tournament or derby that has objective of taking coyotes for cash or prizes.

Note change: Work sessions for HB 2171, HB 2531, HB 2549, and HB 2728 have been added.
