HB 2549

CARRIED OVER FROM THE 3/18/2021 MEETING: Requires agencies to send copies of reports on public access sites to State Marine Board and for board to make reports public, including by hosting map of reported sites on website.

HB 2531

CARRIED OVER FROM THE 3/18/2021 MEETING: Adds State Forestry Department, Department of Transportation and State Department of Fish and Wildlife as consulting agencies for state pollinator health outreach and education plan.

HB 2032

CARRIED OVER FROM THE 3/18/2021 MEETING: Establishes that Department of State Lands or State Department of Agriculture rules implementing traditionally maintained channels program may provide for implementation on region-by-region basis.

HB 2033

CARRIED OVER FROM THE 3/18/2021 MEETING: Authorizes State Department of Agriculture to deputize veterinary technicians to assist department in carrying out its duties.

**Public Hearing and Possible Work Session**

HB 2245

(3:40 pm) Prohibits Department of State Lands from imposing civil penalty for violation of removal-fill laws in wetland if wetland was not listed on wetlands inventory and person committing violation did not have actual knowledge that site was wetland.

HB 2246

(4:00 pm) Prohibits Director of Department of State Lands from requiring enhancement of wetlands to correct violation of removal-fill law.

HB 2068

Makes provisions regarding issuance and use of landowner preference tags for hunting wildlife permanent.

HB 2645

Exempts dog training facilities from state structural specialty codes.

HB 2548

Directs Legislative Policy and Research Office to study issues related to funding construction of wildlife corridor road crossings and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.
