HJM 3

CARRIED OVER FROM THE 3/25/2021 MEETING: Urges Congress to pass and President to sign Emergency Wildfire and Public Safety Act of 2020.

HJM 6

CARRIED OVER FROM THE 3/25/2021 MEETING: Urges Congress to enact legislation promoting cooperative fuel load measurement and management on federal and state lands.

#### **Public Hearing and Possible Work Session**

HB 3163

(3:20 pm) Amends residency requirements for purposes of licenses, tags and permits related to wildlife.

HB 3152

(3:40 pm) Authorizes State Department of Fish and Wildlife to operate wildlife inspection stations for purposes of preventing spread of infections or infestations harmful to wildlife or of furthering wildlife management efforts.

HB 2246

(4:00 pm) Prohibits Director of Department of State Lands from requiring enhancement of wetlands to correct violation of removal-fill law.

#### **Work Session**

HB 2611

Prevents application of state structural specialty code to agricultural building used primarily for specified activities.

HB 2691

Directs State Department of Energy to conduct study to identify techniques to increase visibility to birds of rotor blades on wind energy facilities and evaluate suitability of techniques for use in Oregon.

HB 2068

Makes provisions regarding issuance and use of landowner preference tags for hunting wildlife permanent.

HB 2733

Removes prohibition against issuing dog license without proof of rabies inoculation.

HB 2610 \*\*

\*\*Subsequent Referral(s) to Water

Provides that State Fish and Wildlife Commission may waive requirement that artificial obstruction in waters of this state provide for fish passage if commission determines that artificial obstruction will be repaired or replaced and is less than eight feet tall, or that artificial obstruction is dam that provides hydropower, drinking water or water for irrigation use, artificial obstruction provides fish habitat and providing for fish passage would increase cost of project by more than 10 percent.

HB 2548

Directs Legislative Policy and Research Office to study issues related to funding construction of wildlife corridor road crossings and report to appropriate committee or interim committee of
