HB 2386 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 3/25/2021 MEETING: Creates Oregon Independent Science Review Board.

HB 3173 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 3/25/2021 MEETING: Removes requirement that amount of net proceeds from Oregon State Lottery allocated to County Fair Account not exceed \$1.53 million annually.

HJM 6

CARRIED OVER FROM THE 3/25/2021 MEETING: Urges Congress to enact legislation promoting cooperative fuel load measurement and management on federal and state lands.

HB 2611

Prevents application of state structural specialty code to agricultural building used primarily for specified activities.

HB 2068

Makes provisions regarding issuance and use of landowner preference tags for hunting wildlife permanent.

Public Hearing and Possible Work Session

HB 3163

(4:00 pm) Amends residency requirements for purposes of licenses, tags and permits related to wildlife.

HB 3152

(4:15 pm) Authorizes State Department of Fish and Wildlife to operate wildlife inspection stations for purposes of preventing spread of infections or infestations harmful to wildlife or of furthering wildlife management efforts.

HB 2246

(4:30 pm) Prohibits Director of Department of State Lands from requiring enhancement of wetlands to correct violation of removal-fill law.

HB 2610 **

**Subsequent Referral(s) to Water

Provides that State Fish and Wildlife Commission may waive requirement that artificial obstruction in waters of this state provide for fish passage if commission determines that artificial obstruction will be repaired or replaced and is less than eight feet tall, or that artificial obstruction is dam that provides hydropower, drinking water or water for irrigation use, artificial obstruction provides fish habitat and providing for fish passage would increase cost of project by more than 10 percent.

HB 2548

Directs Legislative Policy and Research Office to study issues related to funding construction of wildlife corridor road crossings and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

Please note: HB 3187 and HB 2691 were removed and rescheduled to the 4/6/2021 meeting. HB 2733 has been removed.
