HB 2724

CARRIED OVER FROM THE 4-6-2021 AGENDA: Requires State Department of Agriculture to establish advisory committee to advise department on policies related to Oregon crops.

HB 3114 \*\* \*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Oregon Ocean Science Trust, State Department of Fish and Wildlife and Higher Education Coordinating Commission in certain amounts for certain purposes related to ocean chemistry.

HB 2281 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs State Department of Agriculture to administer Oregon Hemp State Program for production, processing and sale of hemp.

HB 2284 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Oregon Hemp Commission.

HB 2671

Directs State Department of Agriculture to issue research license to qualified applicant.

HB 3187 \*\*
Establishes Oregon Wildlife Council.

HB 2572

Provides that spread of fire in forestland across ownership boundary does not constitute prima facie evidence of fire burning uncontrolled if owners or operators of forestland on both sides of ownership boundary agree in advance to conduct prescribed fire.

HB 2661 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-6-2021 AGENDA: Appropriates moneys to State Department of Fish and Wildlife for purpose of funding programs that award \$5 for each take of pikeminnow, if take complies with wildlife laws.

HB 2795 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-6-2021 AGENDA: Appropriates moneys to State Forestry Department for purpose of facilitating projects pursued under Good Neighbor Authority Agreement that reduce wildfire risks.

HB 3167

CARRIED OVER FROM THE 4-6-2021 AGENDA: Repeals sunset of predator damage control district program.

HB 3249 \*\*

\*\*Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4-6-2021 AGENDA: Directs State Department of Agriculture, in consultation with Minor Crops Advisory Committee, to establish grant program to study alternatives to chlorpyrifos.

Note change: HB 3075 has been removed. A public hearing for HB 2724 has been removed.

### Register to testify live remotely:

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
