- HB 2281 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs State Department of Agriculture to administer Oregon Hemp State Program for production, processing and sale of hemp.
- HB 2284 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Oregon Hemp Commission.
- HB 2671  
Directs State Department of Agriculture to issue research license to qualified applicant.
- HB 3187 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes Oregon Wildlife Council.
