Public Hearing

HB 2377

Permits claims against insurance assets of dissolved business entities notwithstanding certain time limitations that otherwise would bar claims.

HB 2393

Removes option to elect, for uninsured motorist coverage, coverage limits that fall below coverage limits applicable to personal injury protection benefits.

HB 2043

Directs insurer to consider only specified information in determining rates for motor vehicle liability insurance policy.
