Work Session

HB 2375

Provides for restoration of retirement credit for member of Oregon Public Service Retirement Plan who forfeited retirement credit due to lack of service at end of 2020.

HB 2393

Removes option to elect, for uninsured motorist coverage, coverage limits that fall below coverage limits applicable to personal injury protection benefits.

HB 2415

Requires Department of Consumer and Business Services to conduct study to evaluate feasibility of and develop standards and specifications for system that allows for performing electronic field inspections and construction progress inspections and to verify compliance with building code requirements on site.

HB 2867 **

**Subsequent Referral(s) to Revenue

Directs Public Employees Retirement Board to initiate, resume or suspend payment of certain increased benefits under Public Employees Retirement System on first day of calendar quarter

following receipt of notice by board that benefit payments are or are not subject to Oregon personal income tax.

HB 3130 ** **Subsequent Referral(s) to Ways and Means
Provides that certain substitute teachers are considered employees of school district and are eligible for retirement benefits and health benefit plans.

HB 3206
Expands permissible uses of amounts in Employment Department Special Fraud Control Fund, including payment of costs associated with federal Lost Wages Assistance program.

HB 2946
CARRIED OVER FROM THE 3/24/2021 AGENDA: Requires parties to franchise agreement to deal in good faith and commercially reasonable manner, and specifies required disclosures in franchise sale transaction.

HB 2043
CARRIED OVER FROM THE 3/24/2021 AGENDA: Directs insurer to consider only specified information in determining rates for motor vehicle liability insurance policy.

Public Hearing

HB 2374
(3:20 PM) Directs Oregon Department of Administrative Services to study issues related to preferences in public contracting and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

HB 2358
(3:35 PM) Prohibits employers from permitting or requiring agricultural workers to work in excess of 40 hours in one workweek unless workers are compensated for overtime hours worked.

Note change: HB 2946 and HB 2043 have been carried over from the 3/24/2021 agenda.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
