Work Session

HB 2343

Authorizes governing body of enterprise zone sponsor to adopt resolution suspending enterprise zone employment requirements otherwise imposed on authorized business firms.

HB 2356

Prohibits certain financial institutions from charging fee to customer for cashing check drawn on account at financial institution, if check is presented in Oregon.

HB 2374

Directs Oregon Department of Administrative Services to study issues related to preferences in public contracting and report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2022.

HB 3029

Requires Employment Relations Board to develop guidelines and procedures for authorizations designating bargaining representatives of bargaining unit to be prepared and signed electronically.

HB 3171

Includes insurance in definition of real estate, goods and services that are subject to penalties for unlawful trade practices.

HB 3188

Changes definitions of "employer" and "worker" for purposes of workers' compensation law.

AGENDA (cont.)
April 5, 2021

HB 3272

Requires insurer that provides coverage for full replacement costs of damaged or destroyed property to allow insured not less than 24 months of additional living expenses and not less than 24 months within which to repair, rebuild or replace damaged or lost property or, if damage or loss to the property results from emergency or major disaster, not less than 36 months of additional living expenses and time within which to repair, rebuild or replace damaged or lost property.

HB 2393

CARRIED OVER FROM 3/29/2021 AGENDA: Removes option to elect, for uninsured motorist coverage, coverage limits that fall below coverage limits applicable to personal injury protection benefits.

HB 2946

CARRIED OVER FROM 3/29/2021 AGENDA: Requires parties to franchise agreement to deal in good faith and commercially reasonable manner, and specifies required disclosures in franchise sale transaction.

HB 2043

CARRIED OVER FROM 3/29/2021 AGENDA: Directs insurer to consider only specified information in determining rates for motor vehicle liability insurance policy.

HB 2875

CARRIED OVER FROM 3/31/2021 AGENDA Directs Public Employees Retirement Board to study public employee retirement and report to appropriate committee or interim committee of Legislative Assembly no later than September 15, 2022.

HB 2375

CARRIED OVER FROM 3/31/2021 AGENDA Provides for restoration of retirement credit for member of Oregon Public Service Retirement Plan who forfeited retirement credit due to lack of service at end of 2020.

HB 2867 **

**Subsequent Referral(s) to Revenue

CARRIED OVER FROM 3/31/2021 AGENDA Directs Public Employees Retirement Board to initiate, resume or suspend payment of certain increased benefits under Public Employees Retirement System on first day of calendar quarter following receipt of notice by board that benefit payments are or are not subject to Oregon personal income tax.
