HB 3354

(1:15 pm) Directs Teacher Standards and Practices Commission to adopt standards for educator preparation programs relating to evaluations of teacher candidates.

HB 2136

(1:45 pm) Clarifies terminology of persons who may be investigated or disciplined by Teacher Standards and Practices Commission.

HB 2962

(2:00 pm) Requires each school district to evaluate instructional needs of students of school district as result of school closures due to COVID-19 and to report summaries of evaluations to Department of Education.
